HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB24-1217 be amended as follows:

- 1 Amend the Health and Human Services Committee Report, dated
- 2 February 27, 2024, strike page 1 and substitute:
 - 3 "Amend printed bill, page 2, line 3, strike "(14.5), and (17.5)" and
 - 4 substitute "and (14.5)".
- 5 Page 2 of the bill, line 8, strike "27-50-111" and substitute "27-50-110".
- 6 Page 2 of the bill, strike lines 14 and 15.
- 7 Page 2 of the bill, lines 16 and 17, strike "27-50-109, 27-50-110, and
- 8 27-50-111" and substitute "27-50-109 and 27-50-110".
- 9 Strike pages 3 and 4 of the bill.
- 10 Page 5 of the bill, strike line 1.
- 11 Renumber succeeding C.R.S. sections accordingly."
- 12 Page 2 of the report, strike lines 1 through 18.
- 13 Page 2 of the report, strike lines 30 through 32 and substitute:
- 14 "Page 7 of the bill, strike lines 4 through 20 and substitute:
 - 15 "(1) (a) ON OR BEFORE JULY 1, 2025, THE BHA SHALL CREATE A FRIENDS
 - 16 AND FAMILY INPUT FORM TO ALLOW AN INDIVIDUAL TO PROVIDE A
 - 17 TREATING PROFESSIONAL OR A LICENSED OR DESIGNATED FACILITY OR
 - 18 ORGANIZATION WITH INFORMATION RELATED TO A PATIENT RECEIVING
 - 19 MENTAL HEALTH OR SUBSTANCE USE SERVICES, INCLUDING:
 - 20 (I) INFORMATION ABOUT A PATIENT'S:
 - 21 (A) DIAGNOSIS;
 - 22 (B) PAST HOSPITALIZATIONS;
 - 23 (C) DE-ESCALATION TECHNIQUES;
 - 24 (D) CURRENT AND PAST PROVIDERS AND THEIR CONTACT
 - 25 INFORMATION;
 - 26 (E) POTENTIAL TRIGGERS;
 - 27 (F) HOUSING STATUS;
 - 28 (G) FAMILY HISTORY, RELATIONSHIPS, OR SOCIAL CONTEXT;
 - 29 (H) CURRENT MEDICAL CONDITIONS; AND
 - 30 (I) CURRENT AND PAST MEDICATIONS; AND

- 1 (II) ANY OTHER INFORMATION AS DETERMINED BY THE BHA
2 BASED ON FEEDBACK RECEIVED FROM STAKEHOLDERS.
- 3 (b) THE FRIENDS AND FAMILY INPUT FORM MUST INCLUDE A CLEAR
4 STATEMENT THAT THE FRIENDS AND FAMILY INPUT FORM MAY BECOME
5 PART OF THE PATIENT'S MEDICAL RECORD."."
- 6 Page 2 of the report, line 33, strike "ENTITY, UNLESS A" and substitute
7 "ENTITY IF A PATIENT EXPRESSLY PROHIBITS DISCLOSURE, EXCEPT IF A
8 COURT OR OTHER LEGAL AUTHORITY HAS ORDERED THE DISCLOSURE."."
- 9 Page 3 of the report, strike lines 1 through 3.
- 10 Page 3 of the report, line 7, strike "SHALL NOT" and substitute "IS NOT
11 REQUIRED TO".
- 12 Page 3 of the report, after line 8, insert:
- 13 "Page 8 of the bill, line 26, strike "(4) (a)" and substitute "(4)".
- 14 Page 9 of the bill, strike lines 3 through 10.
- 15 Page 10 of the bill, strike line 27 and substitute:
- 16 "(8) THE BHA SHALL PROMULGATE RULES FOR BEHAVIORAL
17 HEALTH SAFETY NET PROVIDERS RELATED TO MAINTAINING AND
18 RELEASING PATIENT INFORMATION AND IMPLEMENTING THE FRIENDS AND
19 FAMILY INPUT FORM."
- 20 Page 11 of the bill, strike line 1."
