- 1 Amend printed bill, page 9, line 17, after "(3)(d)" insert "and (3)(e)".
- 2 Page 10, line 12, strike "FOLLOWING INFORMATION ABOUT" and substitute
3 "DEMOGRAPHIC INFORMATION, INCLUDING RACE, ETHNICITY, GENDER,
4 AGE, SEXUAL ORIENTATION, GENDER IDENTITY, AND DISABILITY STATUS,
5 TO THE EXTENT THE INFORMATION IS AVAILABLE, OF THE".
- 6 Page 10, line 16, strike "PLACEMENT:" and substitute "PLACEMENT;".
- 7 Page 10, strike lines 17 through 25.
- 8 Page 11, line 1, after "AREA;" add "AND".
- 9 Page 11, lines 4 and 5, strike "19-2.5-1514; AND" and substitute
10 "19-2.5-1514."
- 11 Page 11, strike lines 6 and 7, and substitute:
12 "(e) (I) THE WORKING GROUP SHALL CONDUCT A STUDY TO
13 DETERMINE HOW TO IDENTIFY, WHO POSSESSES, AND THE BEST METHOD TO
14 COLLECT AND REPORT, THE FOLLOWING DATA AND INFORMATION RELATED
15 TO JUVENILES WHO ARE DETAINED:".
- 16 Page 11, line 8, after "REQUESTED" insert "IN EACH JUDICIAL DISTRICT".
- 17 Page 11, line 14, after "YOUTH" insert "IN EACH JUDICIAL DISTRICT".
- 18 Page 11, after line 17, insert:
19 "(C) THE NUMBER OF YOUTH ELIGIBLE FOR RELEASE FROM A
20 DETENTION FACILITY WITHOUT AN ADDITIONAL COURT ORDER WHO, AFTER
21 BEING HELD IN DETENTION FOR A PERIOD OF TIME DUE TO A LACK OF
22 AVAILABLE SERVICES OR PLACEMENT, ARE RELEASED FROM DETENTION
23 WITHOUT THE IDENTIFIED SERVICES OR PLACEMENT, AND THE NUMBER OF
24 DAYS BETWEEN THE IDENTIFICATION OF THE NEED FOR SERVICES OR
25 PLACEMENT AND RELEASE, FOR EACH YOUTH.
26 (II) THE WORKING GROUP SHALL INCLUDE THE RESULTS OF THE
27 STUDY IN ITS RECOMMENDATIONS MADE PURSUANT TO SUBSECTION
28 (3)(a)(III) OF THIS SECTION."
- 29 Page 11, strike lines 18 through 20.
