

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB20-1151 be amended as follows:

1 Amend printed bill, page 15, line 25, strike "(3)" and substitute "(4)".

2 Page 16, after line 18 insert:

3 "(3) BEFORE COMMENCING CONSTRUCTION OF A REGIONAL
4 TRANSPORTATION SYSTEM, A TRANSPORTATION PLANNING ORGANIZATION
5 EXERCISING THE POWERS OF AN AUTHORITY SHALL ANALYZE AND
6 DOCUMENT TO THE DEPARTMENT OF TRANSPORTATION THE SYSTEM'S
7 ANTICIPATED IMPACTS ON THE ACHIEVEMENT OF THE STATE GREENHOUSE
8 GAS POLLUTION GOALS SET FORTH IN SECTION 25-7-102 (2)(g) AND ON
9 COMPLIANCE WITH APPLICABLE STANDARDS UNDER THE ATTAINMENT
10 PROGRAM CREATED AND DEVELOPED PURSUANT TO PART 3 OF ARTICLE 7
11 OF TITLE 25. UPON THE REQUEST OF A RURAL TRANSPORTATION PLANNING
12 ORGANIZATION, THE DEPARTMENT OF TRANSPORTATION SHALL PROVIDE
13 TECHNICAL ASSISTANCE TO FACILITATE THE COMPLETION OF THE
14 ANALYSIS. THE TRANSPORTATION PLANNING ORGANIZATION SHALL ALSO
15 SUBMIT THE ANALYSIS TO THE AIR QUALITY CONTROL COMMISSION
16 CREATED IN SECTION 25-7-104 (1) AND SHALL NOT COMMENCE
17 CONSTRUCTION OF THE REGIONAL TRANSPORTATION SYSTEM UNTIL THE
18 COMMISSION HAS REVIEWED AND APPROVED IT IN ACCORDANCE WITH
19 COMMISSION RULES ADOPTED PURSUANT TO SECTION 25-7-105 (1)(f)." .

20 Rerumber succeeding subsection accordingly.

21 Page 16, after line 25 insert:

22 "**SECTION 9.** In Colorado Revised Statutes, 25-7-105, **add** (1)(f)
23 as follows:

24 **25-7-105. Duties of commission - rules - legislative declaration**

25 **- definitions.** (1) Except as provided in sections 25-7-130 and 25-7-131,
26 the commission shall promulgate such rules and regulations as are
27 consistent with the legislative declaration set forth in section 25-7-102
28 and necessary for the proper implementation and administration of this
29 article 7, including, but not limited to:

30 (f) RULES THAT DEFINE CONFORMANCE AND MEASUREMENT OF
31 CONFORMANCE WITH STATE GREENHOUSE GAS GOALS AND APPLICABLE
32 ATTAINMENT PROGRAM STANDARDS IN NONATTAINMENT AREAS FOR ANY
33 REGIONAL TRANSPORTATION SYSTEM, AS DEFINED IN SECTION 43-4-602
34 (16), PROPOSED TO BE COMPLETED BY A TRANSPORTATION PLANNING
35 ORGANIZATION, AS DEFINED IN SECTION 43-4-602 (19), EXERCISING THE
36 POWERS OF A REGIONAL TRANSPORTATION AUTHORITY." .

37 Rerumber succeeding sections accordingly.
