- 3 Page 2, line 6, strike "(8)(b.3)" and substitute "(8)(f)".
- 4 Page 2, line 7, after "**or**" insert "**detached**".
- 5 Page 3, after line 6 insert:
6 "(II) ~~An~~ A VALID identification card issued in accordance with
7 section 42-2-302; ~~C.R.S.~~;
8 (IV) A VALID military identification card;

- 17 Page 5, line 27, after "basis." add "FOR THE PURPOSES OF THIS
18 SUBSECTION (8)(d), A TRANSACTION BETWEEN A DEALER AND A MOTOR
19 VEHICLE DEALER IS NOT A WHOLESALE SALE."
- 20 Page 7, after line 16 insert:
21 "(11) THIS SECTION DOES NOT APPLY TO DETACHED CATALYTIC
22 CONVERTERS ACQUIRED AS PART OF A WHOLE MOTOR VEHICLE
23 TRANSACTION IN WHICH AN AUTO PARTS RECYCLER, AS DEFINED IN
24 SECTION 42-4-2201 (1), REPORTS THE MOTOR VEHICLE ACQUISITION INTO
25 THE NATIONAL MOTOR VEHICLE TITLE INFORMATION SYSTEM, AS
26 DESCRIBED IN 49 U.S.C. SEC. 30504."

28 NUMBER."
- 29 Renumber succeeding section accordingly.
- 30 Insert "DETACHED" before "CATALYTIC" on: **Page 2**, line 14; **Page 3**, lines
31 3, 8, 11, 13, 16, 21, 23, and 24; **Page 4**, lines 2, 4, 6, 14, 17, 22, and 24;

- 1 **Page 5**, lines 4, 11, 13, and 27; **Page 6**, lines 8, 11, 15, 19, 21, and 22;
- 2 and **Page 7**, lines 2, 5, 8, 13, and 15.
