Committee on Transportation & Energy.

HB22-1348 be amended as follows:

- 1 Amend reengrossed bill, page 5, strike lines 22 through 25 and substitute:
2 "(III) Ensuring that operators disclose chemical information to the
3 state, local governments, and communities in close proximity to
4 operations after the operations have commenced; and".
- 5 Page 6, line 3, after "production;" insert "and".
- 6 Page 6, strike lines 4 and 5.
- 7 Page 8, line 17, after "GAS" insert "PRODUCTION".
- 8 Page 10, line 17, strike "ESTIMATED AMOUNT" and substitute
9 "CONCENTRATION".
- 10 Page 12, line 20, before "US" insert "UNIQUE NUMERICAL IDENTIFIER
11 ASSIGNED BY THE AMERICAN PETROLEUM INSTITUTE TO THE WELL WHERE
12 DOWNHOLE OPERATIONS ARE BEING OR WILL BE CONDUCTED AND THE".
- 13 Page 14, line 3, strike "ESTIMATED AMOUNT" and substitute
14 "CONCENTRATION".
- 15 Page 14, line 10, strike "SEVEN" and substitute "THIRTY".
- 16 Page 17, line 5, before "COMMISSION" insert "DIRECTOR OF THE".
- 17 Page 17, line 7, strike "MANUFACTURER BY CERTIFIED MAIL." and
18 substitute "MANUFACTURER".
- 19 Page 17, line 12, before "COMMISSION" insert "DIRECTOR OF THE".
- 20 Page 19, strike lines 19 through 26 and substitute:
21 "(II) THE COMMISSION SHALL PRESENT THE ANNUAL REPORT TO
22 THE TRANSPORTATION AND ENERGY COMMITTEE OF THE SENATE AND THE
23 ENERGY AND ENVIRONMENT COMMITTEE OF THE HOUSE OF
24 REPRESENTATIVES, OR THEIR SUCCESSOR COMMITTEES, DURING THE
25 COMMITTEES' HEARINGS HELD PRIOR TO THE 2026 REGULAR SESSION, AND
26 EACH SESSION THEREAFTER, OF THE GENERAL ASSEMBLY UNDER THE
27 "STATE MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND
28 TRANSPARENT (SMART) GOVERNMENT ACT", PART 2 OF ARTICLE 7 OF
29 TITLE 2. THE COMMISSION SHALL ALSO POST THE REPORT ON THE
30 COMMISSION'S WEBSITE."
