- 1 Amend printed bill, page 7, after line 24 insert:
- 2 "(i) (I) "DIRECT VENDOR" MEANS ANY DISTRIBUTOR, SUPPLIER, OR
- 3 OTHER ENTITY THAT SELLS OR SUPPLIES ONE OR MORE CHEMICAL
- 4 PRODUCTS DIRECTLY TO AN OPERATOR OR SERVICE PROVIDER FOR USE AT
- 5 A WELL SITE.
- 6 (II) "DIRECT VENDOR" DOES NOT INCLUDE ENTITIES THAT
- 7 MANUFACTURE, PRODUCE, OR FORMULATE CHEMICAL PRODUCTS FOR
- 8 FURTHER MANUFACTURE, FORMULATION, SALE, OR DISTRIBUTION BY
- 9 THIRD PARTIES PRIOR TO BEING SUPPLIED DIRECTLY TO OPERATORS OR
- 10 SERVICE PROVIDERS.
- 11 (j) "DISCLOSER" MEANS AN OPERATOR, ANY SERVICE PROVIDER
- 12 USING ONE OR MORE CHEMICAL PRODUCTS IN THE COURSE OF DOWNHOLE
- 13 OPERATIONS, AND ANY DIRECT VENDOR THAT PROVIDES ONE OR MORE
- 14 CHEMICAL PRODUCTS DIRECTLY TO THE OPERATOR OR SERVICE PROVIDER
- 15 FOR USE AT A WELL SITE."
- 16 Reletter succeeding paragraphs accordingly.
- 17 Page 16, strike lines 6 through 10.
- 18 Reletter succeeding paragraphs accordingly.
- 19 Page 16, lines 11 through 12, strike "INFORMATION COVERED BY THE
- 20 TRADE SECRET CLAIM CONSTITUTES A TRADE SECRET:" and substitute
- 21 "TRADE SECRET CLAIM IS COMPLETE:".
- 22 Page 16, strike lines 17 through 27.
- 23 Page 17, strike lines 1 through 4.
- 24 Page 19, after line 18 insert:
- 25 "(12) NOTWITHSTANDING ANY LAW TO THE CONTRARY, NOTHING
- 26 IN THIS SECTION OR THE RULES PROMULGATED BY THE COMMISSION
- 27 PURSUANT TO THIS SECTION PREVENTS THE COMMISSION, THE STATE, OR
- 28 A LOCAL GOVERNMENT FROM COLLECTING CHEMICAL DISCLOSURE
- 29 INFORMATION FROM DISCLOSERS OR OPERATORS UNDER ANY OTHER
- 30 PROVISION OF LAW."
