HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB22-1063 be amended as follows:

1 Amend the Judiciary Committee Report, dated February 9, 2022, page 1,
2 strike lines 1 and 2 and substitute:

3 "Amend printed bill, page 3, strike lines 2 through 4 and substitute:

4 "SECTION 1. In Colorado Revised Statutes, **add** part 19 to
5 article 3 of title 2 as follows:

6 PART 19".

7 Page 3, after line 5 insert:

8 "2-3-1901. **Legislative oversight committee for Colorado jail**
9 **standards - creation - duties.** (1) **Creation.** (a) THERE IS CREATED A
10 LEGISLATIVE OVERSIGHT COMMITTEE CONCERNING COLORADO JAIL
11 STANDARDS, REFERRED TO IN THIS PART 19 AS THE "COMMITTEE".

12 (b) THE COMMITTEE CONSISTS OF SIX MEMBERS. THE PRESIDENT
13 OF THE SENATE, THE MINORITY LEADER OF THE SENATE, THE SPEAKER OF
14 THE HOUSE OF REPRESENTATIVES, AND THE MINORITY LEADER OF THE
15 HOUSE OF REPRESENTATIVES SHALL APPOINT THE MEMBERS OF THE
16 COMMITTEE AS FOLLOWS:

17 (I) THE PRESIDENT OF THE SENATE SHALL APPOINT TWO SENATORS
18 TO SERVE ON THE COMMITTEE AND DESIGNATE ONE OF THE SENATORS AS
19 THE VICE-CHAIR OF THE COMMITTEE, AND THE MINORITY LEADER OF THE
20 SENATE SHALL APPOINT ONE SENATOR TO SERVE ON THE COMMITTEE;

21 (II) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
22 APPOINT TWO REPRESENTATIVES TO SERVE ON THE COMMITTEE AND
23 DESIGNATE ONE OF THE REPRESENTATIVES AS THE CHAIR OF THE
24 COMMITTEE, AND THE MINORITY LEADER OF THE HOUSE OF
25 REPRESENTATIVES SHALL APPOINT ONE REPRESENTATIVE TO SERVE ON THE
26 COMMITTEE;

27 (III) THE PRESIDENT OF THE SENATE, THE MINORITY LEADER OF
28 THE SENATE, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE
29 MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES SHALL MAKE THEIR
30 APPOINTMENTS BY JULY 1, 2022. IN THE CASE OF A VACANCY, THE PERSON
31 MAKING THE ORIGINAL APPOINTMENT OR REAPPOINTMENT SHALL FILL ANY
32 VACANCY BY APPOINTMENT.

33 (c) (I) MEMBERS OF THE COMMITTEE MAY RECEIVE PAYMENT OF
34 PER DIEM AND REIMBURSEMENT FOR ACTUAL AND NECESSARY EXPENSES
35 AUTHORIZED PURSUANT TO SECTION 2-2-307.

36 (II) THE DIRECTOR OF RESEARCH OF THE LEGISLATIVE COUNCIL
37 AND THE DIRECTOR OF THE OFFICE OF LEGISLATIVE LEGAL SERVICES SHALL
38 SUPPLY STAFF ASSISTANCE TO THE COMMITTEE, BUT SHALL NOT SUPPLY
39 STAFF ASSISTANCE TO ANY SUBCOMMITTEES CREATED BY THE COMMITTEE.

1 (2) **Duties.** (a) THE COMMITTEE SHALL MEET NO MORE THAN FOUR
2 TIMES EACH YEAR.

3 (b) THE COMMITTEE IS RESPONSIBLE FOR THE OVERSIGHT OF THE
4 COMMISSION. THE CHAIR OF THE COMMITTEE SHALL ESTABLISH
5 ORGANIZATIONAL RULES AND PROCEDURAL RULES AS ARE NECESSARY FOR
6 THE OPERATION OF THE COMMISSION.

7 (c) THE COMMITTEE MAY INTRODUCE UP TO A TOTAL OF THREE
8 BILLS, JOINT RESOLUTIONS, OR CONCURRENT RESOLUTIONS DURING THE
9 2024 LEGISLATIVE SESSION. BILLS THAT THE COMMITTEE INTRODUCES ARE
10 EXEMPT FROM THE FIVE-BILL LIMITATION SPECIFIED IN RULE 24 (b)(1)(A)
11 OF THE JOINT RULES OF THE SENATE AND THE HOUSE OF REPRESENTATIVES.
12 JOINT RESOLUTIONS AND CONCURRENT RESOLUTIONS THAT THE
13 COMMITTEE INTRODUCES ARE EXEMPT FROM THE LIMITATIONS SET OUT IN
14 RULE 26 (g) OF THE RULES OF THE HOUSE OF REPRESENTATIVES AND RULE
15 30 (f) OF THE RULES OF THE SENATE. THE COMMITTEE IS EXEMPT FROM
16 THE REQUIREMENT TO REPORT BILLS OR OTHER MEASURES TO THE
17 LEGISLATIVE COUNCIL AS SPECIFIED IN RULE 24 (b)(1)(D) AND RULE 24A
18 (d)(8) OF THE JOINT RULES OF THE SENATE AND THE HOUSE OF
19 REPRESENTATIVES AND IN SECTION 2-3-303 (1)(f), COLORADO REVISED
20 STATUTES. THE COMMITTEE IS SUBJECT TO RULE 24A OF THE JOINT RULES
21 OF THE SENATE AND HOUSE OF REPRESENTATIVES, EXCEPT TO THE EXTENT
22 THAT THE RULE MAY CONFLICT WITH THIS PART 19. BILLS RECOMMENDED
23 BY THE COMMITTEE MUST BE INTRODUCED BY THE INTRODUCTION
24 DEADLINE FOR HOUSE BILLS SPECIFIED IN RULE 23 (a)(1) OF THE JOINT
25 RULES OF THE SENATE AND HOUSE OF REPRESENTATIVES. THE CHAIR AND
26 VICE-CHAIR SHALL JOINTLY ESTABLISH THE LAST DATE FOR THE MEETING
27 AT WHICH THE COMMITTEE MAY APPROVE BILL REQUESTS, THE LAST DATE
28 BY WHICH COMMITTEE MEMBERS MUST FINALIZE BILL DRAFTS OR BY
29 WHICH BILL DRAFTS WILL BE DEEMED FINALIZED FOR FISCAL NOTE
30 PURPOSES, AND THE LAST DATE BY WHICH THE COMMITTEE WILL CONSIDER
31 AND TAKE FINAL ACTION ON BILL DRAFTS.

32 (d) THE COMMITTEE SHALL RECEIVE AND APPROVE THE REPORT OF
33 THE COMMISSION REQUIRED BY SECTION 2-3-1903 (2).".

34 Page 3, line 6, strike "**17-26-401.**" and substitute "**2-3-1902.**".

35 Page 3, line 8, strike "IN THE DEPARTMENT OF PUBLIC SAFETY".

36 Page 3, line 9, strike "PART 4" and substitute "PART 19", and strike
37 "CREATE" and substitute "RECOMMEND".".

38 Page 1 of the report, strike lines 3 and 4 and substitute:

39 "Page 3, line 11, strike "PART 4 AS "JAILS", AND UPDATE THE" and

1 substitute "PART 19 AS "JAILS"."."

2 Page 2 of the report, line 2, strike ""JULY 31, 2022."" and substitute
3 ""JULY 31, 2022. THE COMMISSION SHALL MEET MONTHLY. THE CHAIR OF
4 THE COMMITTEE SHALL APPOINT A CHAIR AND VICE-CHAIR FROM AMONG
5 THE COMMISSION MEMBERS."".

6 Page 2 of the report, strike line 4 and substitute:
7 "Page 6, line 4, strike "**17-26-402. Commission - duties - rules.**" and
8 substitute "**2-3-1903. Commission - duties - report.**"."

9 Page 2 of the report, strike lines 14 through 19 and substitute:
10 "RECOMMENDATIONS AND PRESENT IT TO THE COMMITTEE FOR APPROVAL
11 BY NOVEMBER 15, 2023. THE DIRECTOR OF RESEARCH OF THE
12 LEGISLATIVE COUNCIL SHALL SUPPLY STAFF ASSISTANCE TO THE
13 COMMISSION, INCLUDING ASSISTING WITH COMPLETING THE REPORT. THE
14 DIRECTOR OF RESEARCH OF THE LEGISLATIVE COUNCIL SHALL NOT SUPPLY
15 STAFF ASSISTANCE TO ANY SUBCOMMITTEES CREATED BY THE
16 COMMISSION."".

17 Page 2 of the report, after line 20 insert:
18 "Page 21, line 5, strike "**17-26-403.**" and substitute "**2-3-1904.**", and
19 strike "PART 4" and substitute "PART 19"."
