

SENATE COMMITTEE OF REFERENCE AMENDMENT
Committee on Judiciary.

HB22-1326 be amended as follows:

- 1 Amend reengrossed bill, page 34, strike lines 8 through 14 and substitute:
2 "(b) (I) STARTING ON OR BEFORE JULY 1, 2023, A COMMUNITY
3 CORRECTIONS PROGRAM ESTABLISHED PURSUANT TO THIS SECTION SHALL
4 DEVELOP PROTOCOLS TO IDENTIFY WITHDRAWAL SYMPTOMS, DETERMINE
5 WHETHER A MEDICAL REFERRAL IS NEEDED, AND ENSURE INDIVIDUALS
6 HAVE ACCESS TO APPROPRIATE MEDICAL PROFESSIONALS AS NECESSARY.
7 IN INSTANCES WHEN A MEDICALLY SUPERVISED DETOXIFICATION APPEARS
8 NECESSARY, COMMUNITY CORRECTIONS PROGRAM STAFF SHALL ASSIST
9 THE INDIVIDUAL WITH ACCESSING A LOCAL EMERGENCY PROVIDER OR
10 MANAGED SERVICE ORGANIZATION FOR NECESSARY TREATMENT.
11 (II) STARTING ON OR BEFORE JULY 1, 2023, A COMMUNITY
12 CORRECTIONS PROGRAM ESTABLISHED PURSUANT TO THIS SECTION SHALL
13 PROVIDE MEDICATION-ASSISTED TREATMENT. IF A COMMUNITY
14 CORRECTIONS PROGRAM DOES NOT PROVIDE MEDICATION-ASSISTED
15 TREATMENT, COMMUNITY CORRECTIONS PROGRAM STAFF SHALL ASSIST
16 THE INDIVIDUAL WITH ACCESSING A COMMUNITY-BASED MEDICATION-
17 ASSISTED TREATMENT PROVIDER. A COMMUNITY CORRECTIONS PROGRAM
18 THAT DOES NOT PROVIDE A MEDICATION-ASSISTED TREATMENT PURSUANT
19 TO THIS SUBSECTION (12), SHALL SUBMIT A REPORT BY JULY 1, 2023, TO
20 THE DIVISION OF CRIMINAL JUSTICE IN THE DEPARTMENT OF PUBLIC SAFETY
21 DESCRIBING THE BARRIERS TO OFFERING THE SERVICES AND WHAT
22 RESOURCES ARE NECESSARY TO PROVIDE MEDICATION-ASSISTED
23 TREATMENT.".
