14 REPRESENTED BY COURT-APPOINTED COUNSEL, OR IS OTHERWISE UNABLE
15 TO AFFORD THE COST OF THE PLACEMENT.".

- 17 Page 18, strike line 12 and 13 and substitute "THE RESIDENTIAL

19 CASH FUND, EXISTING PURSUANT TO SECTION 18-19-103(4), FOR A PERSON
20 ON PROBATION AND IS DETERMINED BY THE COURT TO BE INDIGENT, IS
21 REPRESENTED BY COURT-APPOINTED COUNSEL, OR IS OTHERWISE UNABLE
22 TO AFFORD THE COST OF THE PLACEMENT.".

- 23 Page 20, line 11, strike "A PERSON WHO".

- 24 Page 20, strike lines 12 and 13, and substitute "THE RESIDENTIAL
25 PLACEMENT COSTS MUST BE PAID FROM THE CORRECTIONAL TREATMENT
26 CASH FUND, EXISTING PURSUANT TO SECTION 18-19-103(4), FOR A PERSON
27 ON PROBATION AND IS DETERMINED BY THE COURT TO BE INDIGENT, IS
28 REPRESENTED BY COURT-APPOINTED COUNSEL, OR IS OTHERWISE UNABLE
29 TO AFFORD THE COST OF THE PLACEMENT.".
