SB19-007 be amended as follows:

- 1 Amend printed bill, page 8, line 9, strike "JANUARY" and substitute
- 2 "OCTOBER".
- 3 Page 8, line 13, strike "AND".
- 4 Page 8, after line 13 insert:
- 5 "(II) A STATEMENT AS TO HOW THE INSTITUTION IS PROVIDING
- 6 INFORMATION TO STUDENTS ON HOW TO RECEIVE SUPPORT REGARDING
- 7 SEXUAL MISCONDUCT AS REQUIRED BY SUBSECTION (4) OF THIS SECTION
- 8 AND HOW IT IS PROMOTING THE INFORMATION REQUIRED BY SUBSECTION
- 9 (5) OF THIS SECTION; AND".
- 10 Renumber succeeding subparagraph accordingly.
- 11 Page 8, line 17, strike "JANUARY" and substitute "OCTOBER".
- 12 Page 8, line 22, strike "AND".
- 13 Page 8, after line 22 insert:
- 14 "(II) A STATEMENT AS TO ANY CHANGES IN THE MANNER IN WHICH
- 15 THE INSTITUTION PROVIDES OR PROMOTES THE INFORMATION REQUIRED BY
- 16 SUBSECTION (4) OR (5) OF THIS SECTION; AND".
- 17 Renumber succeeding subparagraph accordingly.
- 18 Page 8, after line 25 insert:
- 19 "(8) BEGINNING IN 2020, AND EVERY YEAR THEREAFTER, THE
- 20 DEPARTMENT SHALL INCLUDE AS PART OF ITS "STATE MEASUREMENT FOR
- 21 ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT (SMART)
- 22 GOVERNMENT ACT" HEARING REQUIRED BY SECTION 2-7-203
- 23 INFORMATION CONCERNING THE REPORTS SUBMITTED BY INSTITUTIONS
- 24 PURSUANT TO SUBSECTION (7)(a) OF THIS SECTION.".
- 25 Renumber succeeding subsection accordingly.
- 26 Page 10, line 9, strike "(8)(b)(VII) AND (8)(b)(VIII)" and substitute
- 27 "(9)(b)(VII) AND (9)(b)(VIII)".
- 28 Page 10, line 13, strike "(8)(a)" and substitute "(9)(a)".
- 29 Page 10, line 21, strike "(8)(d)(I)" and substitute "(9)(d)(I)".
