- 1 Amend House Health & Human Services Committee Report, dated
2 February 18, 2026, before line 1, insert:
3 "Amend printed bill, page 3, line 3, strike "(23); and **add** (23.5)
4 and (24.5)" and substitute "(23)".
- 5 Page 1 of the report, line 1, strike "Amend printed bill, page 3," and
6 substitute "Page 3,".
- 7 Page 1 of the report, strike lines 8 through 10, and substitute:
8 "Page 4, strike lines 2 through 20.
- 9 Page 4, line 24, strike "**immunity.**" and substitute "**immunity -**
10 **definitions.**".
- 11 Page 4, after line 24 insert:
12 "(1) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
13 REQUIRES:
14 (a) "CHILD ADVOCACY CENTER MULTIDISCIPLINARY TEAM" MEANS
15 A GROUP OF PROFESSIONALS WHO WORK COLLABORATIVELY WITH A CHILD
16 ADVOCACY CENTER ON BEHALF OF CHILDREN SERVED BY A CHILD
17 ADVOCACY CENTER TO SHARE INFORMATION TO INFORM THE
18 INVESTIGATION AND PROSECUTION OF CHILD MALTREATMENT AND TO
19 COORDINATE SERVICES IN RESPONSE TO REPORTS OF CHILD
20 MALTREATMENT. A CHILD ADVOCACY CENTER MULTIDISCIPLINARY TEAM
21 MUST INCLUDE, AT A MINIMUM, THE FOLLOWING PROFESSIONALS:
22 (I) A MEMBER OF A LAW ENFORCEMENT AGENCY;
23 (II) A DISTRICT ATTORNEY OR ASSISTANT DISTRICT ATTORNEY;
24 (III) A MEMBER OF THE DEPARTMENT'S CHILD PROTECTIVE
25 SERVICES UNIT;
26 (IV) A LOCAL MENTAL HEALTH PROVIDER;
27 (V) A LOCAL HEALTH-CARE PROVIDER;
28 (VI) A VICTIM ADVOCATE; AND
29 (VII) CHILD ADVOCACY CENTER STAFF.
30 (b) "CHILD MALTREATMENT" MEANS CONDUCT THAT INVOLVES
31 SEXUAL OR PHYSICAL ABUSE OF A CHILD, NEGLECT OF A CHILD, HUMAN
32 TRAFFICKING OF A CHILD, OR EXPLOITATION OF A CHILD."
- 33 Renumber succeeding subsections accordingly.
- 34 Page 5, line 9, strike "(1)(a) AND (1)(b)" and substitute "(2)(a) AND
35 (2)(b)".
- 36 Page 2 of the report, before line 1, insert:
37 "Page 6, line 1, strike "(2)(b)" and substitute "(3)(b)".
- 38 Page 2 of the report, line (6), strike "(2)(b)" and substitute "(3)(b)".
