HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 5, strike line 8 and substitute "**amend** (2); and
2 **add** (2.5) as follows:".

3 Page 5, line 20, strike "CHILD," and substitute "CHILD WHO WAS UNDER
4 EIGHTEEN YEARS OLD," and strike the second "OR".

5 Page 5, after line 23 insert:

6 "(D) A MISDEMEANOR ENUMERATED AS GROUNDS FOR DENIAL,
7 ANNULMENT, SUSPENSION, OR REVOCATION, OF A LICENSE, CERTIFICATE,
8 ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION 22-60.5-107
9 (2)(b), REGARDLESS OF THE DATE OF CONVICTION; OR".

10 Page 5, strike lines 24 through 27.

11 Page 6, strike lines 1 through 21 and substitute:

12 "(b) That ~~he or she has~~ THEY HAVE been convicted of committing
13 ~~any~~ A felony; ~~or~~ A misdemeanor ~~but not including~~ FOR WHICH, AS AN
14 ELEMENT OF THE OFFENSE, THE VICTIM WAS AN AT-RISK PERSON, AS
15 DEFINED IN SECTION 18-6.5-102, OR A CHILD WHO WAS UNDER EIGHTEEN
16 YEARS OLD, REGARDLESS OF THE DATE OF CONVICTION; ANY OTHER
17 MISDEMEANOR IN THE SEVEN YEARS AFTER THE DATE OF THE DISPOSITION
18 OF THE CONVICTION, EXCLUDING ~~any~~ misdemeanor traffic offense or
19 ~~traffic infraction~~; OR A MISDEMEANOR ENUMERATED AS GROUNDS FOR
20 DENIAL, ANNULMENT, SUSPENSION, OR REVOCATION OF A LICENSE,
21 CERTIFICATE, ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION
22 22-60.5-107 (2)(b), REGARDLESS OF THE DATE OF CONVICTION. ~~Such~~
23 ~~certification~~ EACH CONVICTION IN THESE FOUR CATEGORIES MUST BE
24 LISTED IN THE CERTIFICATION. FOR EACH CONVICTION LISTED IN THE
25 CERTIFICATION, THE APPLICANT shall specify ~~such~~ THE felony or
26 misdemeanor for which THE APPLICANT WAS convicted, the date of ~~such~~
27 THE conviction, and the court entering the judgment of conviction.

28 (2.5) SUBSECTION (2) OF THIS SECTION DOES NOT ALTER THE
29 DEPARTMENT'S OBLIGATION TO EVALUATE CRIMINAL CONVICTIONS IN
30 ACCORDANCE WITH SECTION 24-5-101."
