HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 4, line 6, strike "(6)(a.5)" and substitute (2.5)".

2 Page 4, line 16, strike "CHILD," and substitute "CHILD WHO WAS UNDER
3 EIGHTEEN YEARS OLD," and strike the second "OR".

4 Page 4, after line 19 insert:

5 "(D) A MISDEMEANOR ENUMERATED AS GROUNDS FOR DENIAL,
6 ANNULMENT, SUSPENSION, OR REVOCATION OF A LICENSE, CERTIFICATE,
7 ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION 22-60.5-107
8 (2)(b), REGARDLESS OF THE DATE OF CONVICTION; OR".

9 Page 4, strike lines 20 through 27.

10 Page 5, strike lines 1 through 6 and substitute:

11 "(II) That ~~he or she has~~ THEY HAVE been convicted of committing
12 ~~any~~ A felony; ~~or~~ A misdemeanor ~~but not including~~ FOR WHICH, AS AN
13 ELEMENT OF THE OFFENSE, THE VICTIM WAS AN AT-RISK PERSON, AS
14 DEFINED IN SECTION 18-6.5-102, OR A CHILD WHO WAS UNDER EIGHTEEN
15 YEARS OLD, REGARDLESS OF THE DATE OF CONVICTION; ANY OTHER
16 MISDEMEANOR IN THE SEVEN YEARS AFTER THE DATE OF THE DISPOSITION
17 OF THE CONVICTION, EXCLUDING any misdemeanor traffic offense or
18 traffic infraction; OR ANY MISDEMEANOR ENUMERATED AS GROUNDS FOR
19 DENIAL, ANNULMENT, SUSPENSION, OR REVOCATION OF A LICENSE,
20 CERTIFICATE, ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION
21 22-60.5-107 (2)(b) REGARDLESS OF THE DATE OF CONVICTION. ~~Such~~
22 ~~certification~~ EACH CONVICTION IN THESE FOUR CATEGORIES MUST BE
23 LISTED IN THE CERTIFICATION. FOR EACH CONVICTION LISTED IN THE
24 CERTIFICATION, THE APPLICANT shall specify ~~such~~ THE felony or
25 misdemeanor for which THE APPLICANT WAS convicted, the date of ~~such~~
26 THE conviction, and the court entering the judgment of conviction.

27 (2.5) SUBSECTION (2) OF THIS SECTION DOES NOT ALTER THE
28 DEPARTMENT'S OBLIGATION TO EVALUATE CRIMINAL CONVICTIONS IN
29 ACCORDANCE WITH SECTION 24-5-101."
