HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 2, strike line 3 and substitute "(2)(a); and **add**
2 (2)(d) as follows:".

3 Page 2, line 14, strike "CHILD," and substitute "CHILD WHO WAS UNDER
4 EIGHTEEN YEARS OLD," and strike the second "OR".

5 Page 2, after line 17 insert:

6 "(D) A MISDEMEANOR ENUMERATED AS GROUNDS FOR DENIAL,
7 ANNULMENT, SUSPENSION, OR REVOCATION OF A LICENSE, CERTIFICATE,
8 ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION 22-60.5-107
9 (2)(b), REGARDLESS OF THE DATE OF CONVICTION; OR".

10 Page 2, strike lines 18 through 20.

11 Page 3, strike lines 1 through 12 and substitute:

12 "(II) That ~~he has~~ THEY HAVE been convicted of committing ~~any~~ A
13 felony; ~~or~~ A misdemeanor ~~but not including~~ FOR WHICH, AS AN ELEMENT
14 OF THE OFFENSE, THE VICTIM WAS AN AT-RISK PERSON, AS DEFINED IN
15 SECTION 18-6.5-102, OR A CHILD WHO WAS UNDER EIGHTEEN YEARS OLD,
16 REGARDLESS OF THE DATE OF CONVICTION; ANY OTHER MISDEMEANOR IN
17 THE SEVEN YEARS AFTER THE DATE OF THE DISPOSITION OF THE
18 CONVICTION, EXCLUDING any misdemeanor traffic offense or traffic
19 infraction; OR A MISDEMEANOR ENUMERATED AS GROUNDS FOR DENIAL,
20 ANNULMENT, SUSPENSION, OR REVOCATION OF A LICENSE, CERTIFICATE,
21 ENDORSEMENT, OR AUTHORIZATION PURSUANT TO SECTION 22-60.5-107
22 (2)(b), REGARDLESS OF THE DATE OF CONVICTION. ~~Such certification~~
23 EACH CONVICTION IN THESE FOUR CATEGORIES MUST BE LISTED IN THE
24 CERTIFICATION. FOR EACH CONVICTION LISTED IN THE CERTIFICATION, THE
25 APPLICANT shall specify ~~such~~ THE felony or misdemeanor for which THE
26 APPLICANT WAS convicted, the date of ~~such~~ THE conviction, and the court
27 entering the judgment of conviction.

28 (2) (d) THIS SUBSECTION (2) DOES NOT ALTER THE DEPARTMENT'S
29 OBLIGATION TO EVALUATE CRIMINAL CONVICTIONS IN ACCORDANCE WITH
30 SECTION 24-5-101."
