HB26-1248 be amended as follows:

1 Amend printed bill, page 8, after line 10 insert:

2 "SECTION 6. In Colorado Revised Statutes, 43-4-203, **amend**
3 (1)(g) as follows:

4 **43-4-203. Sources of revenue.**

5 (1) All net revenue from the following sources shall be paid into
6 and credited to the highway users tax fund as soon as it is received:

7 (g) From the imposition of road usage fees pursuant to section
8 43-4-217 (3) and (4), EXCEPT AS OTHERWISE PROVIDED IN SECTION
9 43-4-217 (8).

10 **SECTION 7.** In Colorado Revised Statutes, 43-4-217, **amend** (8)
11 as follows:

12 **43-4-217. Additional funding - road usage fees - rules -**
13 **legislative declaration - definitions - repeal.**

14 (8) (a) In accordance with section 43-4-203 (1)(f), the state
15 treasurer shall credit all road usage fee revenue collected as required by
16 this section to the highway users tax fund created in section 43-4-201. In
17 accordance with section 43-4-805 (5)(g.5), the state treasurer shall credit
18 all bridge and tunnel impact fee revenue collected as required by this
19 section to the statewide bridge and tunnel enterprise special revenue fund
20 created in section 43-4-805 (3)(a). All fees credited to the highway users
21 tax fund pursuant to this section shall be allocated from the highway users
22 tax fund to the state, counties, and municipalities as required by section
23 43-4-205 (6.8).

24 (b) NOTWITHSTANDING ANY PROVISION OF LAW TO THE
25 CONTRARY, THE STATE TREASURER SHALL CREDIT TO THE STATE HIGHWAY
26 FUND, CREATED IN SECTION 43-1-219, THE FOLLOWING AMOUNTS:

27 (I) ONE-SIXTH OF ALL ROAD USAGE FEE REVENUE COLLECTED ON
28 AND AFTER JANUARY 1, 2027, IN STATE FISCAL YEAR 2026-27;

29 (II) ONE-SEVENTH OF ALL ROAD USAGE FEE REVENUE COLLECTED
30 IN STATE FISCAL YEAR 2027-28; AND

31 (III) ONE-EIGHTH OF ALL ROAD USAGE FEE REVENUE COLLECTED
32 IN STATE FISCAL YEAR 2028-29 OR DURING ANY SUBSEQUENT STATE
33 FISCAL YEAR."
