HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB26-1271 be amended as follows:

1 Amend printed bill, page 10, strike lines 14 through 19 and substitute:  
2 "(C) PREVENTION, EARLY INTERVENTION, AND COMMUNITY  
3 OUTREACH PROGRAMS AND SERVICES CONDUCTED BY PARTICIPATING  
4 ORGANIZATIONS WITHIN THE BEHAVIORAL HEALTH ADMINISTRATIVE  
5 SERVICES ORGANIZATIONS SYSTEM THAT PROVIDE THOSE PROGRAMS AND  
6 SERVICES, WITH PRIORITIZATION FOR PROGRAMS AND SERVICES THAT  
7 SERVE VETERANS, OR INDIAN HEALTH PROGRAMS AND SERVICES  
8 OPERATED BY THE SOUTHERN UTE INDIAN TRIBE, THE UTE MOUNTAIN  
9 UTE TRIBE, OR THE INDIAN HEALTH SERVICE FOR THE BENEFIT OF TRIBAL  
10 COMMUNITIES."

11 Page 16, strike lines 12 through 17 and substitute:  
12 "(B) HIGH-INTENSITY TREATMENT, INPATIENT CAPACITY, AND  
13 CRISIS STABILIZATION PROGRAMS AND SERVICES CONDUCTED BY  
14 PARTICIPATING ORGANIZATIONS WITHIN THE BEHAVIORAL HEALTH  
15 ADMINISTRATIVE SERVICES ORGANIZATIONS SYSTEM THAT PROVIDE THOSE  
16 PROGRAMS AND SERVICES, WITH PRIORITIZATION FOR PROGRAMS AND  
17 SERVICES THAT SERVE VETERANS, OR INDIAN HEALTH PROGRAMS AND  
18 SERVICES OPERATED BY THE SOUTHERN UTE INDIAN TRIBE, THE UTE  
19 MOUNTAIN UTE TRIBE, OR THE INDIAN HEALTH SERVICE FOR THE BENEFIT  
20 OF TRIBAL COMMUNITIES; AND"

21 Page 21, strike lines 25 through 27 and substitute:  
22 "(B) ACCESS TO INTEGRATED BEHAVIORAL HEALTH AND  
23 RECOVERY SERVICES AND PROGRAMS ACROSS THE CONTINUUM OF CARE,  
24 INCLUDING FAMILY-BASED AND COMMUNITY-CENTERED TREATMENT  
25 OPTIONS, FACILITATED BY PARTICIPATING ORGANIZATIONS WITHIN THE  
26 BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATIONS SYSTEM  
27 THAT PROVIDE THOSE PROGRAMS AND SERVICES, WITH PRIORITIZATION  
28 FOR PROGRAMS AND SERVICES THAT SERVE VETERANS, OR INDIAN HEALTH  
29 PROGRAMS AND SERVICES OPERATED BY THE SOUTHERN UTE INDIAN  
30 TRIBE, THE UTE MOUNTAIN UTE TRIBE, OR THE INDIAN HEALTH SERVICE  
31 FOR THE BENEFIT OF TRIBAL COMMUNITIES; AND"

32 Page 22, strike lines 1 through 5.
