HB26-1271 be amended as follows:

1 Amend printed bill, page 13, line 19, after "EFFECTIVE." insert
2 "ADDITIONALLY, THE BEER, CIDER, AND APPLE WINE IMPACT AND
3 RECOVERY ENTERPRISE SHALL RECOMMEND ANY ADJUSTMENT TO THE
4 BEER, CIDER, AND APPLE WINE IMPACT AND RECOVERY FEE TO THE HOUSE
5 OF REPRESENTATIVES FINANCE COMMITTEE AND THE SENATE FINANCE
6 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES, TO ENSURE THAT THE
7 BEER, CIDER, AND APPLE WINE IMPACT AND RECOVERY ENTERPRISE'S
8 REVENUE DOES NOT EXCEED ONE HUNDRED MILLION DOLLARS IN THE FIRST
9 FIVE FISCAL YEARS OF THE ENTERPRISE'S EXISTENCE."

10 Page 19, line 7, after "EFFECTIVE." insert "ADDITIONALLY, THE SPIRITS
11 IMPACT AND RECOVERY ENTERPRISE SHALL RECOMMEND ANY
12 ADJUSTMENT TO THE SPIRITS IMPACT AND RECOVERY FEE TO THE HOUSE
13 OF REPRESENTATIVES FINANCE COMMITTEE AND THE SENATE FINANCE
14 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES, TO ENSURE THAT THE
15 SPIRITS IMPACT AND RECOVERY ENTERPRISE'S REVENUE DOES NOT EXCEED
16 ONE HUNDRED MILLION DOLLARS IN THE FIRST FIVE FISCAL YEARS OF THE
17 ENTERPRISE'S EXISTENCE."

18 Page 24, line 21, after "EFFECTIVE." insert "ADDITIONALLY, THE WINE
19 IMPACT AND RECOVERY ENTERPRISE SHALL RECOMMEND ANY
20 ADJUSTMENT TO THE WINE IMPACT AND RECOVERY FEE TO THE HOUSE OF
21 REPRESENTATIVES FINANCE COMMITTEE AND THE SENATE FINANCE
22 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES, TO ENSURE THAT THE
23 WINE IMPACT AND RECOVERY ENTERPRISE'S REVENUE DOES NOT EXCEED
24 ONE HUNDRED MILLION DOLLARS IN THE FIRST FIVE FISCAL YEARS OF THE
25 ENTERPRISE'S EXISTENCE."
