SB26-114 be amended as follows:

1 Amend printed bill, page 5, after line 16 insert:

2 "SECTION 2. In Colorado Revised Statutes, 44-3-505, **add** (1)(s)
3 and (4)(a)(VI) as follows:

4 **44-3-505. Local license fees.**

5 (1) The applicant shall pay the following license fees to the
6 treasurer of the municipality, city and county, or county where the
7 licensed premises is located annually in advance:

8 (s) FOR EACH PERMIT ISSUED TO SERVE AND SELL ALCOHOL
9 BEVERAGES ACQUIRED FROM WHOLESALERS LICENSED IN THE STATE
10 PURSUANT TO SECTION 44-3-407 AT A MANUFACTURER'S LICENSED
11 PREMISES IN ACCORDANCE WITH SECTION 44-3-402, FIVE HUNDRED
12 DOLLARS.

13 (4) (a) Each application for a license provided for in this article 3
14 and article 4 of this title 44 filed with a local licensing authority must be
15 accompanied by an application fee in an amount determined by the local
16 licensing authority to cover actual and necessary expenses, subject to the
17 following limitations:

18 (VI) (A) FOR A NEW PERMIT ISSUED TO SERVE AND SELL ALCOHOL
19 BEVERAGES ACQUIRED FROM WHOLESALERS LICENSED IN THE STATE
20 PURSUANT TO SECTION 44-3-407 AT A MANUFACTURER'S LICENSED
21 PREMISES IN ACCORDANCE WITH SECTION 44-3-402, AN AMOUNT NOT TO
22 EXCEED ONE THOUSAND DOLLARS, SET BY THE LOCAL LICENSING
23 AUTHORITY; AND

24 (B) FOR A RENEWAL APPLICATION FOR A PERMIT ISSUED TO SERVE
25 AND SELL ALCOHOL BEVERAGES ACQUIRED FROM WHOLESALERS LICENSED
26 IN THE STATE PURSUANT TO SECTION 44-3-407 AT A MANUFACTURER'S
27 LICENSED PREMISES IN ACCORDANCE WITH SECTION 44-3-402, AN AMOUNT
28 NOT TO EXCEED ONE HUNDRED DOLLARS, SET BY THE LOCAL LICENSING
29 AUTHORITY; EXCEPT THAT AN EXPIRED PERMIT RENEWAL AMOUNT MUST
30 NOT EXCEED FIVE HUNDRED DOLLARS."
