

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB26-1306 be amended as follows:

1 Amend printed bill, page 2, line 27, strike "**declaration.**" and substitute  
2 "**declaration - repeal.**".

3 Page 3, line 13, after "(3) (a)" insert "(I)".

4 Page 3, strike lines 15 through 18 and substitute "MAKES A DONATION OF:

5 (A) ON OR BEFORE JUNE 30, 2028, ONE HUNDRED DOLLARS TO THE  
6 WILD HORSE FUND, CREATED IN SECTION 35-66-104, FOR USE BY THE WILD  
7 HORSE POPULATION MANAGEMENT PROGRAM ESTABLISHED IN SECTIONS  
8 35-1-119 AND 35-66-108; OR

9 (B) ON OR AFTER JULY 1, 2028, FIFTY DOLLARS TO THE WILD  
10 HORSE FUND, CREATED IN SECTION 35-66-104, FOR USE BY THE WILD  
11 HORSE POPULATION MANAGEMENT PROGRAM ESTABLISHED IN SECTIONS  
12 35-1-119 AND 35-66-108.

13 (II) THIS SUBSECTION (3)(a)(II) AND SUBSECTION (3)(a)(I)(A) OF  
14 THIS SECTION ARE REPEALED, EFFECTIVE JULY 1, 2028."

15 Page 4, line 5, after "(4)" insert "(a)".

16 Page 4, strike lines 8 through 12 and substitute "EXCEPT THAT, BEGINNING  
17 JULY 1, 2028, THE DEPARTMENT SHALL COLLECT THE FEE SPECIFIED IN  
18 SECTION 42-3-312 AND AN ADDITIONAL ONE-TIME FEE OF TWENTY-FIVE  
19 DOLLARS FOR ISSUANCE OR REPLACEMENT OF THE SPECIAL LICENSE  
20 PLATES. THE STATE TREASURER SHALL CREDIT THE FEE TO THE HIGHWAY  
21 USERS TAX FUND, CREATED IN SECTION 43-4-201.

22 (b) (I) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT SHALL  
23 NOTIFY THE STATE TREASURER OF THE NUMBER OF WILD HORSE LICENSE  
24 PLATES SOLD. THE EXECUTIVE DIRECTOR OF THE DEPARTMENT, THE  
25 COMMISSIONER OF AGRICULTURE, AND THE STATE TREASURER SHALL  
26 JOINTLY DETERMINE THE FREQUENCY OF THE NOTIFICATIONS.

27 (II) UPON RECEIVING THE NOTIFICATION REQUIRED IN SUBSECTION  
28 (4)(b)(I) OF THIS SECTION, THE STATE TREASURER SHALL TRANSFER:

29 (A) TWENTY-FIVE DOLLARS FROM THE WILD HORSE FUND,  
30 CREATED IN SECTION 35-66-104, TO THE COLORADO DRIVES VEHICLE  
31 SERVICES ACCOUNT, CREATED IN SECTION 42-1-211; AND

32 (B) TWENTY-FIVE DOLLARS FROM THE WILD HORSE FUND,  
33 CREATED IN SECTION 35-66-104, TO THE HIGHWAY USERS TAX FUND,  
34 CREATED IN SECTION 43-4-201.

35 (III) THIS SUBSECTION (4)(b) IS REPEALED, EFFECTIVE JULY 1,  
36 2028."

1 Page 5, line 4, before "In" insert "(1)".

2 Page 5, line 11, strike "~~42-3-271~~ 42-3-272" and substitute "42-3-271".

3 Page 5, strike lines 14 and 15 and substitute "license plate by section  
4 42-3-213 (1)(b)(II). The department shall transfer the money from the fee  
5 to the state treasurer who shall credit it THE MONEY FROM THE FEE to the".

6 Page 5, after line 17 insert:

7 "(2) IN ADDITION TO ANY OTHER FEE IMPOSED BY THIS ARTICLE 3,  
8 AN APPLICANT FOR SPECIAL LICENSE PLATES ISSUED UNDER SECTION  
9 42-3-272 SHALL PAY THE FEE IMPOSED IN SUBSECTION (1) OF THIS SECTION  
10 ON OR AFTER JULY 1, 2028, TO BE ISSUED THE SPECIAL LICENSE PLATES."
