HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Transportation, Housing & Local Government.
SB26-150 be amended as follows:

1 Amend reengrossed bill, page 23, after line 10 insert:

2 "SECTION 13. In Colorado Revised Statutes, 32-9-119.7, add
3 (13) as follows:

4 **32-9-119.7. Cost efficiency of transit services - climate goals -**
5 **employee retention goals - subregional service council coordination**
6 **- reporting - plans - definition - repeal.**

7 (13) (a) ON AND AFTER JANUARY 1, 2027, TO SUPPORT THE
8 SUBREGIONAL SERVICE COUNCILS CREATED BY THE DISTRICT, THE
9 DISTRICT SHALL:

10 (I) PROVIDE DEDICATED STAFF TO CO-CHAIR AND SUPPORT EACH
11 SUBREGIONAL SERVICE COUNCIL; AND

12 (II) WORK WITH SUBREGIONAL SERVICE COUNCIL MEMBERS TO
13 IDENTIFY A LOCAL LEADER TO CO-CHAIR EACH SUBREGIONAL SERVICE
14 COUNCIL;

15 (b) ON AND AFTER JULY 1, 2028, THE SUBREGIONAL SERVICE
16 COUNCILS SHALL MADE RECOMMENDATIONS TO THE BOARD ON:

17 (I) ALIGNING DISTRICT TRANSIT SERVICES WITH LOCAL AND
18 REGIONAL PLANS;

19 (II) IMPLEMENTING JOINT PROJECTS TO ADDRESS SERVICE GAPS;

20 (III) LEVERAGING EXISTING INTERGOVERNMENTAL AGREEMENTS
21 AND PROJECTS FOR EXPANDED SERVICE DELIVERY;

22 (IV) IDENTIFYING STRATEGIES TO EXPAND FUNDING; AND

23 (V) CONSIDERATIONS OF EQUITY RIDERSHIP DEMAND AND
24 LONG-TERM REGIONAL GROWTH.

25 (c) THE BOARD SHALL MEET AT LEAST TWO TIMES PER YEAR TO
26 RECEIVE RECOMMENDATIONS FROM THE SUBREGIONAL SERVICE COUNCILS
27 AS DESCRIBED IN SUBSECTION (13)(b) OF THIS SECTION.

28 (d) ANNUALLY BEGINNING IN 2028, THE DISTRICT SHALL REPORT
29 TO THE TRANSPORTATION LEGISLATION REVIEW COMMITTEE CREATED IN
30 SECTION 43-2-145 (1)(a) AND TO A JOINT MEETING OF THE HOUSE OF
31 REPRESENTATIVES TRANSPORTATION, HOUSING, AND LOCAL GOVERNMENT
32 COMMITTEE AND THE SENATE TRANSPORTATION AND ENERGY COMMITTEE,
33 OR THEIR SUCCESSOR COMMITTEES, ON THE SUBREGIONAL SERVICE
34 COUNCIL RECOMMENDATIONS AND THE DISTRICT'S RESPONSES THERETO."
