HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB24-1045 be amended as follows:

1 Amend printed bill, page 8, strike lines 24 and 25 and substitute:

2 "(2) (a) PURSUANT TO SECTION 12-280-603, THE BOARD, IN".

3 Page 9, line 1, after "RULES" insert "NO LATER THAN MAY 1, 2025,".

4 Page 9, line 3, after "ADMINISTER" insert "ONLY FEDERAL DRUG  
5 ENFORCEMENT ADMINISTRATION SCHEDULE III, IV, AND V  
6 FDA-APPROVED PRODUCTS AS".

7 Page 9, strike lines 5 through 10 and substitute:

8 "(b) IN DEVELOPING THE STATEWIDE DRUG THERAPY PROTOCOL,  
9 THE APPLICABLE BOARDS SHALL CONSIDER REQUIREMENTS FOR TRAINING,  
10 INCLUDING A PROGRAM ACCREDITED BY THE ACCREDITATION COUNCIL  
11 FOR PHARMACY EDUCATION, OR ITS SUCCESSOR ENTITY; PATIENT NOTICE  
12 AND CONSENT; PROVIDER REFERRAL CRITERIA; LAB SCREENING AND  
13 TESTING; MONITORING; PATIENT PRIVACY; AND PATIENT FOLLOW-UP CARE  
14 AND COUNSELING. THE RULES DEVELOPED PURSUANT TO SUBSECTION  
15 (2)(a) OF THIS SECTION MUST SPECIFY THAT ANY COLLABORATING  
16 ENTITIES UTILIZING THE PROTOCOL ARE CLEARLY IDENTIFIED.".

17 Page 41, after line 25 insert:

18 "SECTION 23. In Colorado Revised Statutes, **amend** 25.5-5-510  
19 as follows:

20 **25.5-5-510. Pharmacy reimbursement - substance use disorder**  
21 **- injections.** ~~If a pharmacy has entered into a collaborative pharmacy~~  
22 ~~practice agreement with one or more physicians pursuant to section~~  
23 ~~12-280-602 to administer~~ A PHARMACY ADMINISTERING injectable  
24 antagonist medication for medication-assisted treatment for substance use  
25 disorders ~~the pharmacy administering the drug~~ shall receive an enhanced  
26 dispensing fee that aligns with the administration fee paid to a provider  
27 in a clinical setting.".

28 Renumber succeeding sections accordingly.
