

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB24-095 be amended as follows:

1 Amend printed bill, page 12, after line 22 insert:

2 "SECTION 8. In Colorado Revised Statutes, 42-4-306, **amend**
3 (3)(b)(V)(A); and **add** (3)(b)(V)(C) as follows:

4 **42-4-306. Powers and duties of commission - automobile**
5 **inspection and readjustment program - basic emissions program -**
6 **enhanced emissions program - clean screen program.**
7 (3) (b) (V) (A) Notwithstanding any contrary provision in the
8 "Procurement Code", articles 101 to 112 of title 24, ~~C.R.S.~~, or this ~~article~~
9 ARTICLE 4, any contract for inspection services may be renewed for a term
10 not to exceed two years, after which the contract may be renewed for a
11 single term of up to four years or rebid; except that inspection fees during
12 any such four-year renewal contract ~~shall be as determined under~~ ARE
13 SUBJECT TO section 42-4-311 (6).

14 (C) NOTWITHSTANDING ANY CONTRARY PROVISION IN THE
15 "PROCUREMENT CODE", ARTICLES 101 TO 112 OF TITLE 24, OR THIS
16 ARTICLE 4, THE DIVISION SHALL RENEGOTIATE OR RENEW A CONTRACT FOR
17 INSPECTION SERVICES IN EXISTENCE ON JULY 1, 2024, NO LATER THAN
18 OCTOBER 1, 2024, TO ACCOUNT FOR THE FEE ESTABLISHED IN SECTION
19 42-4-311 (6) AS IT WILL BECOME EFFECTIVE ON THE EFFECTIVE DATE OF
20 THIS SUBSECTION (3)(b)(I)(C) AND FOR A TERM NOT TO EXCEED FOUR
21 YEARS, AFTER WHICH THE CONTRACT MAY BE RENEWED FOR A SINGLE
22 TERM OF UP TO FOUR YEARS OR REBID. THE NEW CONTRACT MUST PROVIDE
23 FOR ADDING ADDITIONAL TESTING STATIONS AND EXPANDING THE CLEAN
24 SCREEN INSPECTION UNITS.

25 **SECTION 9.** In Colorado Revised Statutes, 42-4-311, **amend**
26 (4)(a)(I) and (6)(a); **repeal** (6)(b); and **add** (4)(a)(III) as follows:

27 **42-4-311. Operation of inspection and readjustment stations**
28 **- inspection-only facilities - fleet inspection stations - motor vehicle**
29 **dealer test facilities - enhanced inspection centers.** (4) (a) (I) SUBJECT
30 TO SUBSECTION (4)(a)(III) OF THIS SECTION, a licensed inspection and
31 readjustment station, inspection-only facility, or motor vehicle dealer test
32 facility shall charge a fee not to exceed fifteen dollars for the inspection
33 of vehicles, model year 1981 and older, at facilities licensed or authorized
34 within either the basic or enhanced emissions program; except that for
35 1982 model and newer vehicles a test facility may charge a fee not to
36 exceed ~~twenty-five~~ THIRTY-FIVE dollars.

37 (III) THE DIVISION SHALL ANNUALLY ADJUST FOR INFLATION OR
38 DEFLATION THE FEES DESCRIBED IN SUBSECTION (4)(a)(I) OF THIS SECTION.
39 THE DIVISION MAY ROUND THE ADJUSTED AMOUNT UPWARD OR

1 DOWNWARD AS APPROPRIATE. INFLATION OR DEFLATION IS MEASURED BY
2 THE ANNUAL PERCENTAGE CHANGE IN THE UNITED STATES DEPARTMENT
3 OF LABOR'S BUREAU OF LABOR STATISTICS CONSUMER PRICE INDEX, OR A
4 SUCCESSOR INDEX, FOR DENVER-AURORA-LAKEWOOD FOR ALL ITEMS
5 PAID BY URBAN CONSUMERS.

6 (6) (a) The fee charged for enhanced emissions inspections
7 performed within the enhanced emissions program area on 1982 and later
8 motor vehicles ~~shall~~ MUST not be any greater than that determined by the
9 contract and in no case greater than ~~twenty-five~~ THIRTY-FIVE dollars. The
10 fee charged for clean screen inspections performed on vehicles registered
11 in the basic area ~~shall~~ MUST not be any greater than that determined by the
12 contract and in no case greater than fifteen dollars. ~~Such~~ THE fee ~~shall~~
13 MUST not exceed the maximum fee required to be posted by the enhanced
14 inspection center pursuant to section 42-4-305 for the inspection of any
15 motor vehicle required to be inspected under section 42-4-310.

16 (b) ~~During the two-year renewal of the contract entered into~~
17 ~~pursuant to section 42-4-307 (10), the commission shall hold a hearing to~~
18 ~~determine the maximum fee that may be charged pursuant to the contract~~
19 ~~for inspections during any subsequent renewal term. The maximum fee~~
20 ~~must be based on estimated actual operating costs during the life of the~~
21 ~~contract, determined pursuant to the proceeding, plus a percentage to be~~
22 ~~determined by the commission, not to exceed ten percent and not to~~
23 ~~exceed twenty-five dollars."~~
