

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB20-1235 be amended as follows:

- 1 Amend printed bill, page 3, line 20, strike "**definitions.**" and substitute
2 "**definitions - repeal.**".
- 3 Page 7, after line 2 insert:
4 "(b) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (3)(a) OF
5 THIS SECTION, THE FAMILY-SCHOOL PARTNERSHIP COORDINATOR IS NOT
6 REQUIRED TO INCLUDE IN THE COORDINATOR'S REPORT ANY INFORMATION
7 THAT IS INCLUDED IN ANY OTHER REPORT PUBLISHED BY THE
8 DEPARTMENT. FOR ANY INFORMATION OMITTED PURSUANT TO THIS
9 SUBSECTION (3)(b), THE COORDINATOR SHALL INCLUDE IN THE
10 COORDINATOR'S REPORT AN EXPLANATION THAT THE INFORMATION WAS
11 OMITTED AND A REFERENCE TO THE REPORT THAT INCLUDES THE
12 INFORMATION.".
- 13 Reletter succeeding paragraph accordingly.
- 14 Page 7, strike line 5 and substitute "STUDENT ORGANIZATIONS AND TO THE
15 PUBLIC ON ITS WEBSITE IN ENGLISH AND SPANISH. THE DEPARTMENT
16 SHALL ALSO PUBLISH THE REPORT ON ITS WEBSITE IN ANY OTHER
17 LANGUAGE AT THE REQUEST OF A LOCAL PARENT, FAMILY, AND STUDENT
18 ORGANIZATION. NOTWITHSTANDING".
- 19 Page 7, line 6, strike "NOTWITHSTANDING".
- 20 Page 7, line 7, before "SUBMIT" insert "THE DEPARTMENT SHALL".
- 21 Page 7, after line 8 insert:
22 "(d) IN ITS FINAL REPORT BEFORE THE HOUSE AND SENATE
23 COMMITTEES OF REFERENCE PURSUANT TO SECTION 2-7-203 PRIOR TO THE
24 REPEAL OF THIS SECTION, THE DEPARTMENT SHALL INCLUDE A
25 RECOMMENDATION OF WHETHER THE FAMILY-SCHOOL PARTNERSHIP
26 COORDINATOR POSITION SHOULD BE EXTENDED.
27 (4) THIS SECTION IS REPEALED, EFFECTIVE JUNE 30, 2025.".
