- 22 Page 10, strike lines 1 and 2.

- 24 Page 10, line 6, after "SECTION." add "ANY MONEY APPROPRIATED
- 25 PURSUANT TO THIS SUBSECTION (4)(b) THAT IS NOT EXPENDED PRIOR TO
- 26 JULY 1, 2025, REMAINS AVAILABLE FOR EXPENDITURE FOR THE SAME
- 27 PURPOSE IN THE 2025-26 STATE FISCAL YEAR WITHOUT FURTHER
- 28 APPROPRIATION."
