A BILL FOR AN ACT

101 **CONCERNING CRIME PREVENTION THROUGH SAFER STREETS UTILIZING**
102 **DESIGN MANAGEMENT STRATEGIES.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

The bill creates the crime prevention through safer streets grant program (grant program) in the department of public safety (DPS). The bill requires DPS to issue requests for proposals to local governmental agencies for the agencies to identify areas where crime is prevalent. After identifying such areas, local governmental agencies can apply to DPS for grants for improvements designed to create safer streets.

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.
Capital letters or bold & italic numbers indicate new material to be added to existing statute.
Dashes through the words indicate deletions from existing statute.

The bill directs DPS to establish policies and procedures for the grant program. It also creates an advisory committee to review grant requests and make recommendations to the executive director of DPS. The executive director reviews responses to the requests for proposals and grants and determines which local governmental agencies will receive money and the amount of each grant.

The bill appropriates \$10.3 million to DPS for the grant program.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 24-33.5-117 as
3 follows:

4 **24-33.5-117. Crime prevention through safer streets grant**
5 **program - created - committee - reports - repeal.** (1) THERE IS
6 CREATED IN THE DEPARTMENT THE CRIME PREVENTION THROUGH SAFER
7 STREETS GRANT PROGRAM, REFERRED TO IN THIS SECTION AS THE "GRANT
8 PROGRAM". THE GRANT PROGRAM ALLOWS THE DEPARTMENT AND LOCAL
9 GOVERNMENTS TO EVALUATE AND DESIGN SAFER STREETS AND
10 NEIGHBORHOOD MODELS THAT DISCOURAGE CRIME, REVITALIZE
11 COMMUNITY IMAGE, AND ESTABLISH PLACE-SPECIFIC CRIME PREVENTION
12 STRATEGIES THAT ACCOUNT FOR GEOGRAPHIC, CULTURAL, ECONOMIC,
13 AND SOCIAL CHARACTERISTICS OF THE TARGET AREAS. THE DEPARTMENT
14 SHALL ADMINISTER THE GRANT PROGRAM PURSUANT TO THIS SECTION.
15 THE DEPARTMENT SHALL FIRST ISSUE REQUESTS FOR PROPOSALS TO LOCAL
16 GOVERNMENTAL AGENCIES FOR THE AGENCY TO OBTAIN AN ANALYSIS TO
17 IDENTIFY AREAS WHERE CRIME IS MORE PREVALENT. SUBJECT TO
18 AVAILABLE APPROPRIATIONS, THE DEPARTMENT MAY PROVIDE TECHNICAL
19 ASSISTANCE TO AGENCIES INTERESTED IN SUBMITTING RESPONSIVE
20 PROPOSALS. AFTER AREAS WHERE CRIME IS MORE PREVALENT ARE
21 IDENTIFIED, LOCAL GOVERNMENTAL AGENCIES MAY SUBMIT A GRANT
22 APPLICATION TO THE DEPARTMENT FOR A GRANT TO PAY FOR

1 IMPROVEMENTS DESIGNED TO CREATE SAFER STREETS. A LOCAL
2 GOVERNMENTAL AGENCY MAY PARTNER WITH A COMMUNITY-BASED
3 NONPROFIT ORGANIZATION TO SUBMIT A JOINT APPLICATION TO THE
4 DEPARTMENT FOR A GRANT TO PAY FOR IMPROVEMENTS DESIGNED TO
5 CREATE SAFER STREETS. SUCH IMPROVEMENTS MAY INCLUDE:

- 6 (a) BETTER LIGHTING;
- 7 (b) IMPROVED TRASH COLLECTION;
- 8 (c) ACCESS CONTROL;
- 9 (d) TERRITORIAL REINFORCEMENT; AND
- 10 (e) IMPROVED SPACE MANAGEMENT.

11 (2) THE DEPARTMENT SHALL DEVELOP POLICIES AND PROCEDURES:

12 (a) FOR LOCAL GOVERNMENTAL AGENCIES TO SUBMIT RESPONSES
13 TO THE REQUESTS FOR PROPOSALS AND GRANT APPLICATIONS; ==

14 (b) ENSURING THAT MONEY FROM THE GRANT AWARD IS NOT USED
15 FOR:

16 (I) HIRING LAW ENFORCEMENT OR CODE ENFORCEMENT
17 PERSONNEL OR PEACE OFFICERS; OR

18 (II) FACIAL RECOGNITION PURPOSES;

19 (c) ENSURING THAT MONEY FROM THE GRANT AWARD ENHANCES
20 COMMUNITY SAFETY BOTH INSIDE AND OUTSIDE OF URBAN AREAS; AND

21 (d) RELATED TO HOW MONEY IS DISBURSED TO AGENCIES.

22 (3) ALL GRANT APPLICATIONS MUST ADDRESS:

23 (a) THE TARGET AREA AND CRIME CHALLENGE THE APPLICANT
24 HOPES TO ADDRESS;

25 (b) THE SPECIFIC PROJECTS THE GRANT WOULD FUND;

26 (c) DETAILS ON HOW THE APPLICANT HAS COLLABORATED WITH
27 COMMUNITIES AND OTHER AGENCIES IN DEVELOPING THE IMPROVEMENTS

1 TO BE FUNDED UNDER THE APPLICATION; AND

2 (d) ON HOW THE PLAN WOULD PREVENT THE DISPLACEMENT OF
3 HOMELESS POPULATIONS AND HARM TO COMMUNITIES OF COLOR AND
4 VULNERABLE POPULATIONS.

5 (4) PRIOR TO SUBMITTING GRANT APPLICATIONS TO THE
6 DEPARTMENT, LOCAL GOVERNMENT AGENCIES ARE ENCOURAGED TO
7 SOLICIT FEEDBACK AND CONSULT WITH IMPACTED COMMUNITIES,
8 INCLUDING BUT NOT LIMITED TO AREA RESIDENTS AND BUSINESS OWNERS;
9 HOMEOWNERS' ASSOCIATIONS; REGISTERED NEIGHBORHOOD
10 ORGANIZATIONS; AND EXPERTS IN ENVIRONMENTAL DESIGN, INCLUDING
11 URBAN AND TRANSPORTATION PLANNING PROFESSIONALS AND
12 ARCHITECTS WITH RELEVANT EXPERIENCE IN ENVIRONMENTAL DESIGN.

13 (5) THE EXECUTIVE DIRECTOR SHALL:

14 (a) REVIEW RESPONSES TO REQUESTS FOR PROPOSALS TO IDENTIFY
15 AREAS AROUND THE STATE WHERE CRIME IS MORE PREVALENT, SELECT
16 LOCAL GOVERNMENTAL AGENCIES TO RECEIVE MONEY TO IDENTIFY SUCH
17 AREAS, AND DETERMINE THE AMOUNT OF MONEY FOR EACH AGENCY;

18 (b) APPOINT MEMBERS OF THE CRIME PREVENTION THROUGH SAFER
19 STREETS ADVISORY COMMITTEE ESTABLISHED PURSUANT TO SUBSECTION
20 (6) OF THIS SECTION; AND

21 (c) AFTER REVIEWING THE RECOMMENDATIONS OF THE
22 COMMITTEE, SELECT GRANT RECIPIENTS FOR SAFER STREETS, AND
23 DETERMINE THE AMOUNT OF EACH GRANT.

24 (6) (a) THERE IS CREATED IN THE DEPARTMENT THE CRIME
25 PREVENTION THROUGH SAFER STREETS ADVISORY COMMITTEE, REFERRED
26 TO IN THIS SECTION AS THE "COMMITTEE". THE COMMITTEE CONSISTS OF
27 THE FOLLOWING ELEVEN PERSONS, WHO ARE APPOINTED BY THE

- 1 EXECUTIVE DIRECTOR:
- 2 (I) TWO MEMBERS OF LAW ENFORCEMENT;
- 3 (II) TWO ELECTED LOCAL OFFICIALS, ONE FROM AN URBAN
4 COMMUNITY AND ONE FROM A RURAL COMMUNITY;
- 5 (III) AN EXPERT IN SITUATIONAL CRIME PREVENTION;
- 6 (IV) THREE PERSONS FROM ORGANIZATIONS REPRESENTING
7 COMMUNITY INTERESTS;
- 8 (V) AN EXPERT WITH A BACKGROUND IN URBAN OR
9 TRANSPORTATION PLANNING;
- 10 (VI) AN ARCHITECT WITH EXPERIENCE IN ENVIRONMENTAL
11 DESIGN; AND
- 12 (VII) AN EXPERT IN EQUITY, DIVERSITY, AND INCLUSIVITY IN THE
13 LAW ENFORCEMENT OR PUBLIC SAFETY FIELD.

14 (b) MEMBERS OF THE COMMITTEE SERVE WITHOUT COMPENSATION
15 AND WITHOUT REIMBURSEMENT FOR EXPENSES.

16 (c) THE COMMITTEE SHALL REVIEW APPLICATIONS FOR GRANTS
17 FOR SAFER STREETS AND MAKE RECOMMENDATIONS TO THE EXECUTIVE
18 DIRECTOR FOR WHICH GRANTS TO APPROVE AND THE AMOUNT OF EACH
19 GRANT.

20 (7) THE GENERAL ASSEMBLY SHALL APPROPRIATE TEN MILLION
21 THREE HUNDRED THOUSAND DOLLARS IN FISCAL YEAR 2022-23 FROM THE
22 GENERAL FUND FOR THE GRANT PROGRAM.

23 (8) ON OR BEFORE AUGUST 1, 2023, EACH LOCAL GOVERNMENTAL
24 AGENCY THAT RECEIVES A GRANT SHALL PROVIDE A FINAL REPORT TO THE
25 DEPARTMENT DESCRIBING HOW THE GRANT MONEY WAS UTILIZED AND
26 WHAT MEASURABLE OR OBSERVABLE IMPACTS THE USE OF THE GRANT
27 MONEY HAD ON REDUCING CRIME. ON OR BEFORE OCTOBER 1, 2023, THE

1 DEPARTMENT SHALL SUBMIT A SUMMARY OF THE REPORTS TO THE
2 JUDICIARY COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND SENATE,
3 OR TO ANY SUCCESSOR COMMITTEES.

4 (9) THIS SECTION IS REPEALED, EFFECTIVE NOVEMBER 1, 2023.

5 **SECTION 2. Safety clause.** The general assembly hereby finds,
6 determines, and declares that this act is necessary for the immediate
7 preservation of the public peace, health, or safety.
