1 WHEREAS, The Colorado FFA is dedicated to making a positive

3 premier leadership, personal growth, and career success through
4 agricultural education; and

5 WHEREAS, Founded in 1928, the Future Farmers of America has
6 brought together students, teachers, and agribusinesses to solidify support
7 for agricultural education; and

8 WHEREAS, In 1988, the official name was changed to the
9 National FFA Organization; this change was made to recognize that FFA
10 is not only for those interested in farming but also for those with more

2 business, and technology, within and to support production farming; and

3 WHEREAS, The Colorado FFA Foundation seeks human,
4 financial, and in-kind resources to support agricultural education in
5 Colorado for secondary and postsecondary students, adults participating
6 in agricultural education, teachers of agricultural education, and FFA
7 alumni; and

8 WHEREAS, There are opportunities within the Colorado FFA
9 Association for all members in grades seven through twelve and in
10 college to be involved in leadership and agriculture career development;
11 and

12 WHEREAS, Whether a member grew up on a farm, in a suburb,
13 or in an urban area, if they have a passion for judging and public
14 speaking, want to explore the depths of agriscience, or get hands-on
15 experience working in the industry, they are able to acquire such
16 experiences through the diverse opportunities of agricultural education
17 and the FFA; and

18 WHEREAS, We recognize that the Colorado FFA Association and
19 Foundation are growing leaders, building communities, and strengthening
20 agriculture through youth development; now, therefore,
