Summary Information

Overview. The bill authorizes the Health Disparities and Community Grant Program to fund programs that support the human-animal bond.

Types of impacts. The bill is projected to affect the following areas on an ongoing basis:

Summary of Legislation

This bill adds the human-animal bond to the definition of the “social determinants of health” under Colorado’s Health Disparities and Community Grant Program. The bill defines the human-animal bond as the mutually beneficial relations between a person and a pet animal in their care and custody. By including this relationship in the social determinants of health definition, the bill authorizes the grant program to fund programs that support the human-animal bond.

State Expenditures

The Colorado Department of Public Health and Environment (CDPHE) administers the Health Disparities and Community Grant Program. The bill expands the types of grants proposals the CDPHE can consider when awarding funding, which may decrease the amount of grants awarded to other organizations. The General Assembly may, at its discretion, increase the amount of money for the grant program to increase available funding for new types of grants and limit this potential impact. Any administrative changes to the program can be implemented within existing resources and therefore no change in appropriation is required.

Effective Date

The bill takes effect 90 days following adjournment of the General Assembly sine die, assuming no referendum petition is filed.

Departmental Difference

The CDPHE estimates that the bill requires a General Fund appropriation of \$25,627 in FY 2026-27 to fund 0.3 FTE to update grant documentation, develop guidance materials, and support and assess potential new applicants. This fiscal note assumes these tasks are consistent with the routine administrative work the CDPHE already performs, and does not require additional appropriations.
