A BILL FOR AN ACT

101 CONCERNING STATE MONEY THAT WAS USED TO REFINANCE MONEY
102 RECEIVED FROM THE FEDERAL CORONAVIRUS STATE FISCAL
103 RECOVERY FUND, AND, IN CONNECTION THEREWITH,
104 TRANSFERRING UNSPENT STATE MONEY TO THE GENERAL FUND,
105 EXTENDING A DEADLINE FOR THE USE OF STATE MONEY, AND
106 REDUCING APPROPRIATIONS.

Bill Summary

to the general fund on June 30, 2026:

- \$27,905,384 from the refinance discretionary account in the ARPA refinance state money cash fund;
- \$4,085,246.49 from the revenue loss restoration cash fund;
- \$1,974,702.20 from the economic recovery and relief cash fund;
- \$1,005,850.24 from the behavioral and mental health cash fund; and
- \$750,190.06 from the state highway fund.

The bill extends the deadline from December 31, 2026, to June 30, 2027, for the department of human services to spend money appropriated in 2022 from the behavioral and mental health cash fund for capital construction related to a youth neuro-psych facility at the Colorado mental health institute at Fort Logan. The bill delays a corresponding transfer of money from the behavioral and mental health cash fund.

The bill reduces appropriations to the department of health care policy and financing and the department of early childhood.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-75-226.5, **add**
3 (6.5) as follows:

4 **24-75-226.5. ARPA refinance state money cash fund - creation**
5 **- reduction in general fund appropriations - legislative intent -**
6 **definitions - repeal.**

7 (6.5) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
8 FROM THE REFINANCE DISCRETIONARY ACCOUNT TO THE GENERAL FUND
9 TWENTY-SEVEN MILLION NINE HUNDRED FIVE THOUSAND THREE HUNDRED
10 EIGHTY-FOUR DOLLARS.

11 **SECTION 2.** In Colorado Revised Statutes, 24-75-227, **amend**
12 (3.8) as follows:

13 **24-75-227. Revenue loss restoration cash fund - creation -**
14 **allowable uses - definitions - repeal.**

15 (3.8) (a) On June 30, 2025, the state treasurer shall transfer from
16 the fund to the general fund twelve million four hundred sixty-one

1 thousand four hundred ninety-four dollars and ten cents of money that did
2 not originate from the money the state received from the coronavirus state
3 fiscal recovery fund.

4 (b) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
5 FROM THE FUND TO THE GENERAL FUND FOUR MILLION EIGHTY-FIVE
6 THOUSAND TWO HUNDRED FORTY-SIX DOLLARS AND FORTY-NINE CENTS
7 OF MONEY THAT DID NOT ORIGINATE FROM THE MONEY THE STATE
8 RECEIVED FROM THE CORONAVIRUS STATE FISCAL RECOVERY FUND.

9 **SECTION 3.** In Colorado Revised Statutes, 24-75-228, **add** (5.3)
10 as follows:

11 **24-75-228. Economic recovery and relief cash fund - creation**
12 **- allowable uses - interim task force - report - legislative declaration**
13 **- definitions - repeal.**

14 (5.3) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
15 FROM THE FUND TO THE GENERAL FUND ONE MILLION NINE HUNDRED
16 SEVENTY-FOUR THOUSAND SEVEN HUNDRED TWO DOLLARS AND TWENTY
17 CENTS OF MONEY THAT DID NOT ORIGINATE FROM THE MONEY THE STATE
18 RECEIVED FROM THE CORONAVIRUS STATE FISCAL RECOVERY FUND.

19 **SECTION 4.** In Colorado Revised Statutes, 24-75-230, **amend**
20 (4.8); and **add** (4.5) and (4.9) as follows:

21 **24-75-230. Behavioral and mental health cash fund - creation**
22 **- allowable uses - task force - definitions - repeal.**

23 (4.5) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
24 FROM THE FUND TO THE GENERAL FUND ONE MILLION FIVE THOUSAND
25 EIGHT HUNDRED FIFTY DOLLARS AND TWENTY-FOUR CENTS OF MONEY
26 THAT DID NOT ORIGINATE FROM THE MONEY THE STATE RECEIVED FROM
27 THE CORONAVIRUS STATE FISCAL RECOVERY FUND.

1 (4.8) ~~Pursuant to section 24-75-226.5 (6)~~; On December 31, 2026,
2 the state treasurer shall transfer any unexpended and unencumbered
3 money in the fund that originates from the ARPA refinance state money
4 cash fund to the ARPA refinance state money cash fund; EXCEPT THAT,
5 NOTWITHSTANDING SECTION 24-75-226.5 (6), THE STATE TREASURER
6 SHALL NOT TRANSFER UNSPENT MONEY APPROPRIATED FROM THE FUND TO
7 THE DEPARTMENT OF HUMAN SERVICES FOR CAPITAL CONSTRUCTION
8 RELATED TO THE CONSTRUCTION OF A NEURO-PSYCH FACILITY AT THE
9 COLORADO MENTAL HEALTH INSTITUTE AT FORT LOGAN.

10 (4.9) ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER
11 THE UNEXPENDED AND UNENCUMBERED MONEY IN THE FUND THAT DID
12 NOT ORIGINATE FROM THE MONEY THE STATE RECEIVED FROM THE
13 CORONAVIRUS STATE FISCAL RECOVERY FUND TO THE GENERAL FUND.

14 **SECTION 5.** In Colorado Revised Statutes, 24-75-219, **add** (7)(l)
15 as follows:

16 **24-75-219. Transfers - transportation - capital construction -**
17 **definitions.**

18 (7) In addition to any other transfers required by this section:

19 (l) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
20 FROM THE STATE HIGHWAY FUND TO THE GENERAL FUND SEVEN HUNDRED
21 FIFTY THOUSAND ONE HUNDRED NINETY DOLLARS AND SIX CENTS OF
22 MONEY THAT DID NOT ORIGINATE FROM THE MONEY THE STATE RECEIVED
23 FROM THE FEDERAL CORONAVIRUS STATE FISCAL RECOVERY FUND.

24 **SECTION 6. Appropriation to the department of human**
25 **services for the fiscal year beginning July 1, 2022.** In Session Laws of
26 Colorado 2022, **amend** section 10 of chapter 185, (HB22-1283), as
27 amended by section 63 of chapter 429, (HB24-1466), as follows:

1 Section 10. **Capital construction appropriation.** For the 2022-23
2 state fiscal year, \$35,000,000 is appropriated to the department of human
3 services. This appropriation is from the behavioral and mental health cash
4 fund created in section 24-75-230 (2)(a), C.R.S. Of this amount,
5 \$30,236,662 originates from the general fund and \$4,763,338 is of money
6 the state received from the federal coronavirus state fiscal recovery fund.
7 To implement this act, the department may use this appropriation for
8 capital construction related to the construction of a neuro-psych facility
9 at the Colorado mental health institute at Fort Logan. Any money
10 appropriated in this section not expended prior to July 1, 2023, THAT IS OF
11 MONEY THE STATE RECEIVED FROM THE FEDERAL CORONAVIRUS STATE
12 FISCAL RECOVERY FUND is further appropriated to the administration from
13 July 1, 2023, through December 31, 2026, for the same purpose. ANY
14 MONEY APPROPRIATED IN THIS SECTION NOT EXPENDED PRIOR TO JULY 1,
15 2023, THAT DID NOT ORIGINATE FROM THE MONEY THE STATE RECEIVED
16 FROM THE CORONAVIRUS STATE FISCAL RECOVERY FUND IS FURTHER
17 APPROPRIATED TO THE ADMINISTRATION FROM JULY 1, 2023, THROUGH
18 JUNE 30, 2027, FOR THE SAME PURPOSE. Money that originated from the
19 federal coronavirus state fiscal recovery fund shall be obligated and
20 expended in accordance with section 24-75-226, C.R.S.

21 **SECTION 7. Appropriation to the department of health care**
22 **policy and financing for the fiscal year beginning July 1, 2022.** In
23 Session Laws of Colorado 2022, section 6 of chapter 180, (HB 22-1302),
24 **amend** (2), as amended by section 20 of chapter 474, Session Laws of
25 Colorado 2023 (SB 23-214), and as further amended by section 77 of
26 chapter 429, Session Laws of Colorado 2024 (HB 24-1466), as follows:

27 Section 6. **Appropriation.** (2) For the 2022-23 state fiscal year,

1 ~~\$3,000,000~~ \$2,200,000 is appropriated to the department of health care
2 policy and financing for use by the executive director's office, general
3 administration. This appropriation is from the behavioral and mental
4 health cash fund created in section 24-75-230 (2)(a), C.R.S. Of this
5 amount, \$1,245,147 is of money the state received from the federal
6 coronavirus state fiscal recovery fund and ~~\$1,754,853~~ \$954,853 originates
7 from the general fund. To implement this act, the division may use this
8 appropriation for the universal contract for behavioral health services.
9 Any money appropriated in this section that is not expended prior to
10 December 30, 2024, is further appropriated to the department for use
11 prior to December 31, 2026, for the same purpose. Money that originated
12 from the federal coronavirus state fiscal recovery fund shall be obligated
13 and expended in accordance with section 24-75-226, C.R.S.

14 **SECTION 8. Appropriation to the department of early**
15 **childhood for the fiscal year beginning July 1, 2022.** In Session Laws
16 of Colorado 2022, section 8 of chapter 345, (SB 22-213), **amend** (1)
17 introductory portion, (1)(a), (1)(c), (1)(d), and (1)(e), as (1) introductory
18 portion is amended by section 71 of chapter 429, Session Laws of
19 Colorado 2024 (HB 24-1466) as follows:

20 Section 8. **Appropriation.** (1) For the 2022-23 state fiscal year,
21 ~~\$49,500,000~~ \$47,883,011 is appropriated to the department of early
22 childhood. This appropriation is from the economic recovery and relief
23 cash fund created in section 24-75-228 (2)(a), C.R.S., and is based on an
24 assumption that the department will require an additional 9.6 FTE. Of this
25 amount, \$15,464,449 is of money the state received from the federal
26 coronavirus state fiscal recovery fund and ~~\$34,035,551~~ \$32,418,562
27 originates from the general fund. To implement this act, the department

1 may use this appropriation for:

2 (a) ~~\$16,000,000~~ \$14,656,182 for use by the early learning access
3 and quality division for the emerging and expanding child care grant
4 program, which amount is based on an assumption that the division will
5 require an additional 3.5 FTE;

6 (c) ~~\$15,000,000~~ \$14,737,721 for use by the early learning access
7 and quality division for the early care and education recruitment and
8 retention grant and scholarship program, which amount is based on an
9 assumption that the division will require an additional 2.5 FTE;

10 (d) ~~\$7,500,000~~ \$7,492,769 for use by the early learning access and
11 quality division for the family, friend, and neighbor training and support
12 program, which amount is based on an assumption that the division will
13 require an additional 2.8 FTE; and

14 (e) ~~\$1,000,000~~ \$996,339 for use by the community and family
15 support division for the home visiting grant program, which amount is
16 based on an assumption that the division will require an additional 0.3
17 FTE.

18 **SECTION 9. Safety clause.** The general assembly finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, or safety or for appropriations for
21 the support and maintenance of the departments of the state and state
22 institutions.
