**A BILL FOR AN ACT**

101 **CONCERNING THE REPEAL OF THE DECARBONIZATION TAX CREDITS**  
102 **ADMINISTRATION CASH FUND.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. **Joint Budget Committee.** On July 1, 2027, the bill repeals the decarbonization tax credits administration cash fund (fund), which is subject to annual appropriation to the department of revenue and the Colorado energy office to pay for the direct and indirect costs associated with the implementation and administration of various decarbonization tax credits. The bill also makes conforming amendments.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-38.5-120, **amend**  
3 (3); and **repeal** (1)(c), (2), (3.5), (4), and (5) as follows:

4 **24-38.5-120. Decarbonization tax credits administration cash**  
5 **fund - definitions - repeal.**

6 (1) As used in this section, unless the context otherwise requires:

7 (c) "~~Fund~~" means the ~~decarbonization tax credits administration~~  
8 ~~cash fund created in subsection (2) of this section.~~

9 (2) ~~The decarbonization tax credits administration cash fund is~~  
10 ~~hereby created in the state treasury. The fund consists of money credited~~  
11 ~~to the fund pursuant to section 39-29-108 (2)(e)(I) and any other money~~  
12 ~~that the general assembly may appropriate or transfer to the fund.~~

18 (b) ~~This subsection (3.5) is repealed, effective July 1, 2026.~~

19 (4) ~~The state treasurer shall transfer all unexpended and~~  
20 ~~unencumbered money in the fund on June 30, 2024, June 30, 2025, and~~  
21 ~~June 30, 2026, to the general fund; except that the balance of money~~  
22 ~~remaining in the fund not including expended and encumbered money~~  
23 ~~shall not be less than three hundred thousand dollars.~~

11 credit for sustainable aviation fuel production facility created in section  
12 39-22-556. The office shall keep an accounting of all money expended

25 credit for expenditures made in connection with a geothermal energy  
26 project created in section 39-22-552, the geothermal electricity generation  
27 production tax credit created in section 39-22-553, and the heat pump

1 technology and thermal energy network tax credit created in section  
2 39-22-554. The office shall keep an accounting of all money expended  
3 from the fund pursuant to this subsection (7)(d). ~~for purposes of~~  
4 ~~calculating the repayment of the administrative costs required by section~~  
5 ~~24-38.5-120 (3)~~

6 **SECTION 4.** In Colorado Revised Statutes, 24-38.5-506, **amend**  
7 (2)(b) as follows:

10 (2) (b) For state fiscal years 2023-24 and 2024-25, the office and,  
11 subject to annual appropriation, the department of revenue may expend  
12 money in the fund for the administration and implementation of the  
13 electric bicycle tax credit created in section 39-22-555. The office shall  
14 keep an accounting of all money expended from the fund pursuant to this  
15 subsection (2)(b). ~~for purposes of calculating the repayment of the~~  
16 ~~administrative costs required by section 24-38.5-120 (3)~~

17 **SECTION 5.** In Colorado Revised Statutes, 25-7-1405, **amend**  
18 (2)(b) as follows:

19 **25-7-1405. Electrifying school buses grant program cash fund**  
20 **- creation - gifts, grants, and donations - transfer - repeal.**

21 (2) (b) For state fiscal years 2023-24 and 2024-25, and subject to  
22 annual appropriation, the Colorado energy office, created in section  
23 24-38.5-101, and the department of revenue may expend money from the  
24 fund for the administration and implementation of the innovative motor  
25 vehicles and innovative trucks tax credits created in sections 39-22-516.7  
26 and 39-22-516.8 and for the specific ownership tax rate reduction for  
27 electric medium-duty and heavy-duty trucks that are part of a fleet as set

1     forth in section 42-3-107 (1)(a)(IV). The office shall keep an accounting  
2     of all money expended from the fund pursuant to this subsection (2)(b).  
3     ~~for purposes of calculating the repayment of the administrative costs~~  
4     ~~required by section 24-38.5-120 (3)~~

5             **SECTION 6.** In Colorado Revised Statutes, 34-60-122, **repeal**  
6     (5)(f) as follows:

10     ~~million five hundred thousand dollars from the energy and carbon~~

13             ~~(H) This subsection (5)(f) is repealed, effective July 1, 2026.~~

14             **SECTION 7.** In Colorado Revised Statutes, 39-29-108, **amend**

18             (2) (b) Except as set forth in ~~subsections (2)(d) and (2)(e)~~

20     the severance taxes imposed on minerals and mineral fuels under the  
21     provisions of this article after June 30, 2017, fifty percent shall be  
22     credited to the state severance tax trust fund created by section 39-29-109,  
23     and fifty percent shall be credited to the local government severance tax  
24     fund created by section 39-29-110.

18 **SECTION 8. Effective date.** This act takes effect only if House  
19 Bill 26-1405 becomes law, in which case this act takes effect on July 1,  
20 2027.

21 **SECTION 9. Safety clause.** The general assembly finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, or safety or for appropriations for  
24 the support and maintenance of the departments of the state and state  
25 institutions.
