**Fiscal note status:** The final fiscal note reflects the introduced bill. This bill was postponed indefinitely by the House Education Committee on March 4, 2026; therefore, the impacts identified in this analysis do not take effect.

### Summary Information

**Overview.** The bill would have created a working group to study how to implement the College Opportunity Fund for persons incarcerated in Colorado.

**Types of impacts.** The bill would have affected the following areas on a one-time basis:

## Summary of Legislation

---

The bill requires the Department of Higher Education (CDHE) to convene a working group to study how to implement the College Opportunity Fund for persons incarcerated in Colorado. The working group has ten members, including representatives from specified institutions of higher education and the Department of Corrections. Working group members serve without compensation or reimbursement for expenses.

The working group must meet at least three times; the first meeting must be before July 30, 2026 and its work must be complete by December 1, 2026. It may collaborate with any person or entity deemed appropriate to assist, and if requested, other relevant state entities must provide assistance if it is consistent with their duties. The working group must submit a report detailing its findings and recommendations to the House and Senate Education committees.

## Background

---

The College Opportunity Fund provides a stipend for qualifying Colorado resident undergraduate students to pay for a portion of in-state tuition at participating institutions.

## State Expenditures

---

The bill increases workload for CDHE to convene and support the working group, and complete the final report. No change in appropriations is required, as the working group charge aligns with current department work.

The bill also minimally increases workload for Adams State University, Trinidad State College, Pueblo Community College, the University of Colorado-Denver, the Community College System, and the Department of Corrections to have representatives serve on the working group.

## Effective Date

---

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.
