2           **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
3 (9)(a)(II) as follows:

4           **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.** (9) (a) The following statutory  
6 authorizations for the designated advisory committees will repeal on  
7 September 1, 2019:

8           ~~(II) The river outfitter advisory committee created in section~~  
9 ~~33-32-110, C.R.S.;~~

10           **SECTION 2.** In Colorado Revised Statutes, 33-32-110, **repeal** (2)  
11 as follows:

12           **33-32-110. Advisory committee - repeal.** (2) ~~(a) This section is~~  
13 ~~repealed, effective July 1, 2019.~~

14           ~~(b) Prior to its repeal, the advisory committee shall be reviewed~~  
15 ~~as provided for in section 2-3-1203, C.R.S.~~

16           **SECTION 3. Safety clause.** The general assembly hereby finds,  
17 determines, and declares that this act is necessary for the immediate  
18 preservation of the public peace, health, and safety.
