After consideration on the merits, the Committee recommends the following:

HB26-1111 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 4, line 15, before the first "PESTICIDE" insert
- 2 "ELIGIBLE".
- 3 Page 4, line 18, strike "AND RECYCLING".
- 4 Page 4, lines 24 and 25, strike "PESTICIDE PRODUCTS OR RECYCLING OF
- 5 PESTICIDE PRODUCT CONTAINERS;" and substitute "ELIGIBLE PESTICIDE
- 6 PRODUCTS;".
- 7 Page 5, line 11, before the first "PESTICIDE" insert "ELIGIBLE".
- 8 Page 6, lines 11 and 12, strike "PESTICIDE PRODUCTS AND THE RECYCLING
- 9 OF MANY OF THE CONTAINERS FOR THE PESTICIDE PRODUCTS" and

9 FEE;
- 10 (III) SETTING THE AMOUNT OF THE PESTICIDE REGISTRATION
11 PRODUCT DISPOSAL FEE; AND
- 12 (IV) ANY OTHER RULES NECESSARY FOR THE ADMINISTRATION
13 AND IMPLEMENTATION OF THE PROGRAM;".

8 INFLATION. INFLATION IS MEASURED BY THE ANNUAL PERCENTAGE
9 CHANGE IN THE UNITED STATES DEPARTMENT OF LABOR'S BUREAU OF
10 LABOR STATISTICS CONSUMER PRICE INDEX, OR A SUCCESSOR INDEX, FOR
11 DENVER-AURORA-LAKEWOOD FOR ALL ITEMS PAID FOR BY URBAN
12 CONSUMERS."
