Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB26-1272 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Health and Human Services Committee Report, dated March
2 18, 2026, page 1, strike line 5 through 11 and substitute:

3 "Page 9, strike lines 9 through 27 and substitute:

4 "(b) (I) ON OR BEFORE JULY 1, 2028, THE DIVISION SHALL DEVELOP
5 A MODEL TRIIPP THAT INCLUDES WRITTEN PROCEDURES FOR:

6 (A) PROVIDING WORKERS ACCESS TO COOL, POTABLE DRINKING
7 WATER AT NO COST;

8 (B) PROVIDING WORKERS ACCESS TO COOL-DOWN OR WARM-UP
9 REST AREAS;

10 (C) MONITORING WORKPLACE TEMPERATURE CONDITIONS;

11 (D) ACCLIMATIZING NEW OR RETURNING WORKERS DURING THEIR
12 FIRST FOURTEEN DAYS OF ASSIGNMENT;

13 (E) TRAINING WORKERS TO RECOGNIZE SIGNS AND SYMPTOMS OF
14 TEMPERATURE-RELATED INJURY AND ILLNESS;

15 (F) RESPONDING TO TEMPERATURE-RELATED MEDICAL
16 EMERGENCIES; AND

17 (G) OTHER COMPONENTS AND EXEMPTIONS AS NECESSARY.

18 (II) THE DIVISION MAY INCORPORATE BY REFERENCE AND ADAPT
19 ESTABLISHED TRIIPP MODELS.

20 (III) THE DIVISION MAY ADOPT RULES NECESSARY TO IMPLEMENT
21 THIS SECTION.

22 (IV) THE DIVISION SHALL ENSURE THE MODEL TRIIPP IS
23 AVAILABLE ON THE DEPARTMENT'S WEBSITE IN A FORMAT THAT CAN BE
24 VIEWED OR DOWNLOADED.

25 (V) THE DIVISION SHALL REVIEW AND UPDATE THE MODEL TRIIPP
26 AS NECESSARY AND NOT LESS THAN EVERY FIVE YEARS."

1 Strike pages 10 through 12."

2 Amend printed bill, page 13, before line 7 insert:

3 **"SECTION 4. Appropriation.** For the 2026-27 state fiscal year,
4 \$63,382 is appropriated to the department of labor and employment for
5 use by the division of labor standards and statistics. This appropriation is
6 from the general fund and is based on an assumption that the division will
7 require an additional 0.4 FTE. To implement this act, the division may
8 use this appropriation for program costs related to labor standards."

9 Renumber succeeding section accordingly.

10 Page 1, line 102, strike "CHANGE." and substitute "CHANGE, AND, IN
11 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
