After consideration on the merits, the Committee recommends the following:

HB18-1181 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 3, line 6, after "A" insert "NATURAL".
- 2 Page 3, line 20, after "(2.5)" insert "(a)" and after "ANY" insert  
3 "NATURAL".
- 4 Page 3, line 21, strike "SECTION 32-1-103 (5)(f)" and substitute "SECTIONS  
5 32-1-103 (5)(f) AND 32-1-806.5".
- 6 Page 4, line 3, strike "COLORADO." and substitute "COLORADO BUT I AM  
7 A RESIDENT OF THE STATE OF \_\_\_\_\_, COUNTY OF \_\_\_\_\_, AND AM AN  
8 ELIGIBLE ELECTOR IN THE STATE OF \_\_\_\_\_."
- 9 Page 4, after line 17 insert:  
  
10 "(b) IN ORDER TO VOTE IN A SPECIAL DISTRICT ELECTION IN  
11 ACCORDANCE WITH SECTION 32-1-806.5, THE SELF-AFFIRMING OATH OR  
12 AFFIRMATION REQUIRED BY SUBSECTION (2.5)(a) OF THIS SECTION MUST  
13 BE NOTARIZED BY THE ELECTOR."
- 14 Page 5, strike lines 1 and 2 and substitute "**district election - option for  
15 special district to allow owners of taxable property within special  
16 district who are not state residents to vote for district board  
17 members.** (1) ANY SPECIAL DISTRICT ORGANIZED UNDER THE LAWS OF  
18 THE STATE MAY, UPON PASSAGE OF A RESOLUTION BY THE BOARD OF THE

1 DISTRICT, ALLOW AN ELECTOR WHOSE ELIGIBILITY TO VOTE IN A SPECIAL  
2 DISTRICT ELECTION IS ESTABLISHED BY SECTION 32-1-806 (2.5) TO VOTE  
3 FOR CANDIDATES FOR THE BOARD OF DIRECTORS OF THE SPECIAL DISTRICT  
4 IN ACCORDANCE WITH THE REQUIREMENTS OF THIS SECTION. SUBJECT TO  
5 THE REQUIREMENTS OF THIS SECTION, NO PERSON WHO IS DESIGNATED".

6 Page 5, line 7, after "REGISTRATION." add "NOTWITHSTANDING ANY  
7 OTHER PROVISION OF THIS SECTION, THIS SECTION ONLY APPLIES TO A  
8 SPECIAL DISTRICT WHOSE BOARD OF DIRECTORS, BY RESOLUTION, PERMITS  
9 AN ELIGIBLE ELECTOR WHO IS NOT A RESIDENT OF THE STATE TO VOTE IN  
10 ELECTIONS OF THE SPECIAL DISTRICT IN ACCORDANCE WITH THE  
11 REQUIREMENTS OF THIS SECTION.".

12 Page 7, line 3, strike "(3.5)." and substitute

13 "(3.5); AND  
14 (c) SUBMIT A COPY OF THE NOTARIZED SELF-AFFIRMING OATH OR  
15 AFFIRMATION THE ELECTOR HAS EXECUTED PURSUANT TO SECTION  
16 32-1-806 (2.5).".

17 Page 7, after line 12 insert:

18 "(d) THE ELECTOR'S STATE AND COUNTY OF RESIDENCE AND  
19 WHETHER THE ELECTOR IS AN ELIGIBLE ELECTOR OF THE STATE  
20 IDENTIFIED.".

21 Reletter succeeding paragraphs accordingly.

22 Page 8, line 8, strike "(7)(g)" and substitute "(7)(h)".
