After consideration on the merits, the Committee recommends the following:

HB18-1299 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 4, line 20, strike "The" and substitute "EXCEPT  
2 AS PROVIDED IN SUBSECTION (3) OF THIS SECTION, the".

3 Page 6, after line 21 insert:

4 "(3) (a) THE DEPARTMENT NEED NOT PROMULGATE RULES, UNDER  
5 SUBSECTION (1) OF THIS SECTION, THAT IMPLEMENT ELECTRONIC  
6 TRANSACTIONS UNTIL THE DEPARTMENT RECEIVES ADEQUATE GIFTS,  
7 GRANTS, OR DONATIONS TO IMPLEMENT THE PROMULGATED RULES. THE  
8 DEPARTMENT MAY, UPON RECEIVING ADEQUATE GIFTS, GRANTS, OR  
9 DONATIONS, PHASE-IN IMPLEMENTATION OF THIS SECTION AS  
10 REASONABLE. THE DEPARTMENT SHALL NOT USE MONEY FROM THE  
11 GENERAL FUND TO IMPLEMENT THIS SECTION.

12 (b) THIS SUBSECTION (3) DOES NOT AFFECT ANY RULES  
13 PROMULGATED, OR APPROPRIATIONS MADE, BEFORE JULY 1, 2019."

14 Page 10, strike lines 11 through 21 and substitute "**businesses - rules.**

15 (4) NOTWITHSTANDING SUBSECTION (3) OF THIS SECTION, THE  
16 DEPARTMENT MAY, UPON PRESENTATION OF A MANUFACTURER'S INVOICE,  
17 ISSUE A BUSINESS THAT RENTS MOTOR VEHICLES A CERTIFICATE OF TITLE  
18 FOR A NEW MOTOR VEHICLE IF THE BUSINESS SUBMITS A SIGNED AFFIDAVIT  
19 OR A TITLE APPLICATION ATTESTING THAT THE MOTOR VEHICLE IS NEW  
20 AND HAS NOT BEEN ISSUED A CERTIFICATE OF TITLE AND THAT THE  
21 BUSINESS IS ENTITLED TO BE ISSUED A CERTIFICATE OF TITLE FOR THE

1 MOTOR VEHICLE. UPON REQUEST OF THE DEPARTMENT, THE BUSINESS  
2 SHALL MAKE AVAILABLE A SCANNED IMAGE OF THE FRONT OF THE  
3 MANUFACTURER'S CERTIFICATE OF ORIGIN FOR UP TO ONE PERCENT OF THE  
4 REGISTERED VEHICLES OF THE BUSINESS FOR ANY GIVEN MONTH."
