Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB18-1409 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Judiciary Committee Report, dated April 26, 2018, page 2,
2 strike lines 23 through 34 and substitute:
3 **""SECTION 4. In Colorado Revised Statutes, 24-32-120, repeal**
4 (5) as follows:
5 **24-32-120. Justice reinvestment crime prevention initiative -**
6 **program - rules - reports - repeal.** (5) (a) ~~The parole savings fund,~~
7 ~~referred to in this subsection (5) as the "fund", is hereby created in the~~
8 ~~state treasury. The fund consists of money generated by savings created~~
9 ~~in enacting House Bill 17-1326 and appropriated to the fund by the~~
10 ~~general assembly.~~
11 (b) ~~The state treasurer shall credit all interest and income derived~~
12 ~~from the deposit and investment of money in the fund to the fund.~~
13 (c) ~~The state treasurer shall transfer any unexpended and~~
14 ~~unencumbered money remaining in the fund at the end of a fiscal year to~~
15 ~~the general fund.~~
16 (d) ~~Subject to annual appropriation by the general assembly, the~~
17 ~~division of local government may expend money from the fund to provide~~
18 ~~small business lending and grants aimed at reducing crime and promoting~~
19 ~~community development in the target communities of north Aurora and~~
20 ~~southeast Colorado Springs.~~
21 (e) ~~Subject to annual appropriation by the general assembly, the~~
22 ~~department of corrections may expend money from the fund for external~~
23 ~~capacity if the anticipated reduction in the use of private prison beds from~~
24 ~~the parole changes enacted in House Bill 17-1326 are not achieved."~~

1 Page 3, strike lines 1 and 2.

2 Page 3, strike lines 3 through 13 and substitute:

3 **"SECTION 5. Appropriation to the department of corrections**
4 **for the fiscal year beginning July 1, 2017.** In Session Laws of Colorado
5 2017, section 8 of chapter 394, (HB 17-1326), **amend** the introductory
6 portion to (4); **repeal** (4)(d) as follows:

7 Section 8. **Appropriation - adjustments to 2017 long bill.** (4)
8 For the 2017-18 state fiscal year, ~~\$5,865,182~~ \$4,104,042 is appropriated
9 to the department of local affairs. This appropriation is from the general
10 fund. To implement this act, the department may use this appropriation
11 as follows:

12 (d) ~~\$1,761,140 to the parole savings fund created in section 24-32-~~
13 ~~120 (5);~~.

14 **SECTION 6. Appropriation.** For the 2018-19 state fiscal year,
15 \$880,570 is appropriated to the department of public health and
16 environment for use by the prevention services division. This
17 appropriation is from the general fund. To implement this act, the division
18 may use this appropriation for the community crime survivors grant
19 program."."
