<u>SB18-145</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

- Amend printed bill, page 4, line 17, after "(III.5)" insert "(A)" and strike
- 2 "RULES," and substitute "RULES IN CONJUNCTION WITH THE STATE
- 3 MEDICAL SERVICES BOARD," and strike "DECEMBER 31, 2018," and
- 4 substitute "JULY 1, 2019,".
- 5 Page 4, line 18, strike "PROVIDERS" and substitute "VENDORS".
- 6 Page 4, strike lines 19 through 27 and substitute "INCLUDING SUPPORTED
- 7 EMPLOYMENT PROFESSIONALS WHO PROVIDE INDIVIDUAL COMPETITIVE
- 8 INTEGRATED EMPLOYMENT OUTCOMES, AND EXCLUDING THOSE
- 9 PROFESSIONALS EXCLUSIVELY PROVIDING GROUP OR OTHER CONGREGATE

- 22 EMPLOYMENT SERVICES FOR THE COST OF TRAINING AND CERTIFICATION

- Page 6, line 11, strike "MODEL AND" and substitute "MODEL, THE SECTOR
- 12 OF EMPLOYMENT, AND".
- 13 Page 6, line 12, strike "AND".
- 14 Page 6, after line 12 insert:
- 15 "(G) THE NUMBER OF INDIVIDUALS ELIGIBLE FOR EMPLOYMENT
- 16 SERVICES, REGARDLESS OF WHETHER THE INDIVIDUAL IS UTILIZING
- 17 EMPLOYMENT SERVICES; AND".
- 18 Reletter succeeding sub-subparagraph accordingly.
- 19 Page 6, strike lines 19 through 27 and substitute:
- 20 "(k) (I) NO LATER THAN JULY 1, 2019, THE STATE BOARD, IN
- 21 CONJUNCTION WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT,
- 22 SHALL REQUIRE A NATIONALLY RECOGNIZED SUPPORTED EMPLOYMENT
- 23 TRAINING CERTIFICATE OR NATIONALLY RECOGNIZED SUPPORTED
- 24 EMPLOYMENT CERTIFICATION FOR ALL VENDORS OF SUPPORTED
- 25 EMPLOYMENT SERVICES, INCLUDING SUPPORTED EMPLOYMENT
- 26 PROFESSIONALS WHO PROVIDE INDIVIDUAL COMPETITIVE INTEGRATED
- 27 EMPLOYMENT OUTCOMES, AND EXCLUDING THOSE PROFESSIONALS
- 28 EXCLUSIVELY PROVIDING GROUP OR OTHER CONGREGATE SERVICES. THE
- 29 STATE BOARD'S RULES MUST INCLUDE TIME FRAMES FOR COMPLIANCE

- WITH THE TRAINING OR CERTIFICATION REQUIREMENT FOR EXISTING STAFF AND FOR NEWLY HIRED STAFF AND REQUIREMENTS FOR SUPERVISION OF NEWLY HIRED STAFF UNTIL THE STAFF MEMBER HAS COMPLETED THE TRAINING OR CERTIFICATION.
- (II) THE TRAINING OR CERTIFICATION REQUIREMENT IN SUBSECTION (2)(k)(I) OF THIS SECTION IS CONTINGENT UPON APPROPRIATIONS TO THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING FOR REIMBURSEMENT TO VENDORS OF SUPPORTED EMPLOYMENT SERVICES FOR THE COST OF TRAINING AND CERTIFICATION.
- 10 The state board shall adopt rules for administering the
- 11 REIMBURSEMENT TO VENDORS, WHICH REIMBURSEMENT MUST BE THREE
- 12 HUNDRED DOLLARS FOR EACH CERTIFICATION EXAM AND TWELVE
- 13 HUNDRED DOLLARS FOR EACH TRAINING PROGRAM CERTIFICATE, WHICH
- 14 INCLUDES REIMBURSEMENT FOR BOTH THE COST OF THE TRAINING AND
- 15 WAGES PAID TO EMPLOYEES DURING TRAINING. THE STATE BOARD MAY
- 16 INCREASE THE FIXED REIMBURSEMENT AMOUNT OVER TIME BASED ON
- 17 INCREASES IN THE COST OF THE EXAM AND EMPLOYEE WAGES.".
