<u>SB18-146</u> be amended as follows, and as so amended, be referred to the Committee on <u>Finance</u> with favorable recommendation:

1 Amend reengrossed bill, page 9, after line 5 insert:

2 "(III) STATES THAT THE FREESTANDING EMERGENCY DEPARTMENT
3 OR A PHYSICIAN PROVIDING HEALTH CARE SERVICES AT THE
4 FREESTANDING EMERGENCY DEPARTMENT MAY NOT BE A PARTICIPATING
5 PROVIDER IN THE PATIENT'S HEALTH INSURANCE PROVIDER NETWORK;

6 (IV) STATES THAT A PHYSICIAN PROVIDING HEALTH CARE
7 SERVICES AT THE FREESTANDING EMERGENCY DEPARTMENT MAY BILL
8 SEPARATELY FROM THE FREESTANDING EMERGENCY DEPARTMENT FOR THE
9 HEALTH CARE SERVICES PROVIDED TO THE PATIENT;".

10 Renumber succeeding subparagraphs accordingly.

11 Page 9, strike lines 9 through 14.

12 Renumber succeeding subparagraphs accordingly.

Page 10, line 11, strike the second "THE" and substitute "EITHER THE
MAXIMUM FACILITY FEE THAT THE FREESTANDING EMERGENCY
DEPARTMENT CHARGES OR THE RANGE OF THE MINIMUM TO MAXIMUM
AMOUNT OF THE FACILITY FEES THAT THE FREESTANDING EMERGENCY
DEPARTMENT CHARGES; AND".

18 Page 10, strike lines 12 and 13.
