After consideration on the merits, the Committee recommends the following:

HB19-1032 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 21, strike "one of only seven states" and
2 substitute "the only state".
- 3 Page 8, line 9, after "VOLUNTARY," insert "CONTINUOUS,".
- 4 Page 8, line 25, after "ANY" insert "SINGLE".
- 5 Page 11, strike lines 6 through 8 and substitute:
6 "(IV) HOW TO AVOID PURSUING A SEXUAL ENCOUNTER WITH A
7 PERSON OR PERSUADING A PERSON TO PARTICIPATE IN A SEXUAL
8 ENCOUNTER WHEN THAT PERSON HAS NOT PROVIDED CONSENT OR HAS
9 WITHDRAWN CONSENT; AND".
- 10 Page 11, strike line 14 and substitute "DECISION-MAKING, IMPACT SEXUAL
11 HEALTH, AND FACILITATE INCIDENCES OF GENDER-BASED VIOLENCE,
12 INCLUDING THE DELIBERATE USE OF ALCOHOL AND DRUGS TO PERPETRATE
13 SEXUAL VIOLENCE;".
- 14 Page 11, line 26, strike "AND PARENTING." and substitute "PARENTING,
15 AND INFORMATION CONCERNING SECTIONS 18-6-401 (9) AND 19-3-304.5,
16 OR ANY SUCCESSOR LAWS, REFERRED TO GENERALLY AS "SAFE HAVEN
17 LAWS.".
- 18 Page 13, line 18, strike "HUMAN SEXUALITY INSTRUCTION." and substitute

1 "COMPREHENSIVE HUMAN SEXUALITY EDUCATION."

2 Page 21, strike lines 8 through 11 and substitute "MEMBERSHIP OF THE
3 OVERSIGHT ENTITY SHALL AT ALL TIMES REPRESENT DIVERSE COMMUNITY
4 PERSPECTIVE AND MAKE AN EFFORT TO INCLUDE COMMITTEE MEMBERS
5 WHO ARE DIVERSE WITH REGARDS TO DISABILITY, RACE, CREED, COLOR,
6 GENDER, GENDER".

7 Page 21, line 13, strike "OR AGE." and substitute "AGE, ENGLISH
8 PROFICIENCY, INCOME, AND GEOGRAPHIC REGION OF THE STATE,
9 INCLUDING BOTH URBAN AND RURAL AREAS."

10 Page 21, after line 13, insert:

11 "(1.7) THE PARENT REPRESENTATIVE AND YOUTH REPRESENTATIVE
12 DESCRIBED IN SUBSECTIONS (1)(e) AND (1)(f) OF THIS SECTION ARE
13 ENTITLED TO RECEIVE REIMBURSEMENT FOR NECESSARY EXPENSES
14 INCURRED IN THE PERFORMANCE OF THE MEMBER'S DUTIES, INCLUDING
15 DEPENDENT OR ATTENDANT CARE."
