<u>HB19-1161</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

Amend printed bill, page 6, line 9, strike "PILOT" and substitute "SUBJECT
 TO AVAILABLE APPROPRIATIONS, PILOT".

Page 6, lines 14 and 15, strike "AT LEAST FIFTEEN BUT NOT MORE THAN
THIRTY" and substitute "UP TO FIFTEEN".

5 Page 14, strike line 13 and insert:

6 "22-99-105. Appropriation. FOR THE 2019-20 STATE FISCAL 7 YEAR, THE GENERAL ASSEMBLY SHALL APPROPRIATE ONE MILLION ONE 8 HUNDRED THOUSAND DOLLARS FROM THE MARIJUANA TAX CASH FUND, 9 CREATED IN SECTION 39-28.8-501, TO THE DEPARTMENT TO IMPLEMENT 10 THE PILOT PROGRAM. ANY MONEY APPROPRIATED FOR THE PILOT 11 PROGRAM PURSUANT TO THIS SECTION THAT IS NOT EXPENDED PRIOR TO 12 JULY 1, 2020, IS FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE 13 2020-21 THROUGH 2023-24 STATE FISCAL YEARS FOR THE SAME PURPOSE. 14 **22-99-106.** Repeal of article. - 5 INSTRUCTION PURSUANT TO ARTICLE 99 OF TITLE 22.".
- 6 Page 14, before line 15 insert:

7 **"SECTION 2. Appropriation.** For the 2019-20 state fiscal year, 8 \$1,100,000 is appropriated to the department of education. This 9 appropriation is from the marijuana tax cash fund created in section 39-10 28.8-501 (1), C.R.S., and is based on an assumption that the department 11 will require an additional 0.7 FTE. To implement this act, the department 12 may use this appropriation for the health and wellness through 13 comprehensive quality physical education instruction pilot program.".
