Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

<u>HB19-1230</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

Amend the Finance Committee Report, dated April 8, 2019, page 14,
after line 25 insert:

3 **"SECTION 12. Appropriation.** (1) For the 2019-20 state fiscal 4 year, \$399,479 is appropriated to the department of revenue. This 5 appropriation is from the marijuana cash fund created in section 44-11-6 501 (1)(a), C.R.S. To implement this act, the department may use this 7 appropriation as follows:

8 (a) \$316,090 for marijuana enforcement, which amount is based 9 on an assumption that the department will require an additional 3.2 FTE;

10 11 (b) \$2,000 for tax administration IT system (GenTax) support;(c) \$72,023 for the purchase of legal services;

(d) \$4,576 for the purchase of criminal history record checks; and

13

(e) \$4,790 for vehicle lease payments.

14 (2) For the 2019-20 state fiscal year, \$72,023 is appropriated to 15 the department of law. This appropriation is from reappropriated funds 16 received from the department of revenue under subsection (1)(c) of this 17 section and is based on an assumption that the department of law will 18 require an additional 0.3 FTE. To implement this act, the department of 19 law may use this appropriation to provide legal services for the 20 department of revenue.

(3) For the 2019-20 state fiscal year, \$4,576 is appropriated to the
department of public safety for use by the biometric identification and
records unit. This appropriation is from reappropriated funds received

1 from the department of revenue under subsection (1)(d) of this section.

- 2 To implement this act, the unit may use this appropriation to provide
- 3 criminal history record checks for the department of revenue.
- 4 (4) For the 2019-20 state fiscal year, \$4,790 is appropriated to the 5 department of personnel. This appropriation is from reappropriated funds 6 received from the department of revenue under subsection (1)(e) of this 7 action. To implement this set, the department of personnel means this
- 7 section. To implement this act, the department of personnel may use this
- 8 appropriation to provide vehicles for the department of revenue.".
- 9 Renumber succeeding section accordingly.
- 10 Page 14 of the Finance Committee Report, strike line 35 and substitute:
- 11 "official declaration of the vote thereon by the governor.".
- 12 Page 1 of the printed bill, line 101, strike "ESTABLISHMENTS." and
- 13 substitute "ESTABLISHMENTS, AND, IN CONNECTION THEREWITH,
- 14 MAKING AN APPROPRIATION.".".".
