11 (3) (a) THE DIVISION SHALL STUDY THE DEVELOPMENT OF A REAL-TIME
12 SYSTEM FOR JAILS TO KEEP AND MAINTAIN THE INFORMATION REQUIRED
13 BY SECTION 17-26-118.

14 (b) DURING ITS ANNUAL PRESENTATION BEFORE THE JOINT
15 JUDICIARY COMMITTEE OF THE GENERAL ASSEMBLY, OR ANY SUCCESSOR
16 JOINT COMMITTEE, PURSUANT TO SECTION 2-7-203, THE DEPARTMENT
17 SHALL INCLUDE A REPORT CONCERNING PROGRESS MADE TOWARD THE
18 DEVELOPMENT OF THE REAL-TIME SYSTEM DESCRIBED IN SUBSECTION
19 (3)(a) OF THIS SECTION. NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I),
20 THE REPORTING REQUIREMENTS SET FORTH IN THIS SECTION CONTINUE
21 UNTIL THE REPEAL OF THIS SUBSECTION (3).

22 (c) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JANUARY 31,
23 2024."
