After consideration on the merits, the Committee recommends the following:

HB19-1322 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, strike lines 7 and 8 and substitute "(3.5)(b)(I)
- 2 OF THIS SECTION, STATE REVENUES FOR THE 2018-19 STATE FISCAL YEAR
- 3 AND FOR ALL SUCCEEDING STATE FISCAL YEARS, ARE LESS".
  
- 4 Page 3, line 17, after "SECTION." add "NOTWITHSTANDING ANY OTHER
- 5 PROVISION OF THIS SECTION, THE TRANSFER PERMITTED BY THIS
- 6 SUBSECTION (3.5)(a) SHALL NOT BE MADE IN MORE THAN SEVEN TOTAL
- 7 STATE FISCAL YEARS."
  
- 8 Page 5, strike lines 17 and 18 and substitute "(3.5)(b)(I) OF THIS SECTION,
- 9 STATE REVENUES FOR THE 2018-19 STATE FISCAL YEAR AND FOR ALL
- 10 SUCCEEDING STATE FISCAL YEARS,".
  
- 11 Page 5, line 27, after "SECTION." add "NOTWITHSTANDING ANY OTHER
- 12 PROVISION OF THIS SECTION, THE TRANSFER PERMITTED BY THIS
- 13 SUBSECTION (3.5)(a) SHALL NOT BE MADE IN MORE THAN SEVEN TOTAL
- 14 STATE FISCAL YEARS."
  
- 15 Page 8, line 6, strike "and (2)(f)" and substitute "(2)(f), and (3)(c)".
  
- 16 Page 11, after line 15 insert:
  
- 17 "(c) SUBJECT TO THE LIMITATION ON THE PERCENTAGE OF MONEY
- 18 APPROPRIATED FROM THE FUND THAT MAY BE EXPENDED FOR THE

1 ADMINISTRATIVE COSTS OF THE DIVISION IN ADMINISTERING THE FUND  
2 SPECIFIED IN SUBSECTION (3)(b) OF THIS SECTION, THE DIVISION MAY  
3 EXPEND MONEY FROM THE FUND TO HIRE AND EMPLOY INDIVIDUALS IN  
4 ORDER TO FULFILL THE PURPOSES OF HOUSE BILL 19-1322, ENACTED IN  
5 2019."
