<u>HB20-1058</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

Amend printed bill, strike everything below the enacting clause and
 substitute:

3 "SECTION 1. In Colorado Revised Statutes, add 22-20-121 as
4 follows:

5 22-20-121. Behavior analysis services in school - written policy 6 - definition. (1) AS USED IN THIS SECTION, UNLESS THE CONTEXT 7 OTHERWISE REQUIRES "BEHAVIOR ANALYST" MEANS A BOARD CERTIFIED 8 BEHAVIOR ANALYST, A BOARD CERTIFIED ASSISTANT BEHAVIOR ANALYST, 9 OR A REGISTERED BEHAVIOR TECHNICIAN WHO IS OVERSEEN BY A BOARD 10 CERTIFIED BEHAVIOR ANALYST OR BOARD CERTIFIED ASSISTANT BEHAVIOR 11 ANALYST DURING THE NORMAL COURSE OF THE BEHAVIOR ANALYST'S 12 PROFESSIONAL DUTIES.

13 (2) NO LATER THAN JULY 1, 2021, EACH ADMINISTRATIVE UNIT 14 SHALL ADOPT A POLICY CONCERNING BEHAVIOR ANALYSTS PROVIDING 15 MEDICALLY NECESSARY SERVICES TO A STUDENT DURING SCHOOL HOURS. 16 PRIOR TO ADOPTING SUCH POLICY, EACH SCHOOL DISTRICT BOARD OF 17 EDUCATION SHALL DISCUSS, IN PUBLIC AT A REGULARLY SCHEDULED 18 MEETING OF THE SCHOOL DISTRICT BOARD OF EDUCATION, BEHAVIOR 19 ANALYSTS PROVIDING MEDICALLY NECESSARY SERVICES TO A STUDENT 20 DURING SCHOOL HOURS.

21 (3) THE POLICY ADOPTED PURSUANT TO THIS SECTION MUST BE
22 POSTED AND MADE PUBLICLY AVAILABLE ON THE ADMINISTRATIVE UNIT'S

SECTION 2. Act subject to petition - effective date. This act 1 2 takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 3 4 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the 5 state constitution against this act or an item, section, or part of this act 6 within such period, then the act, item, section, or part will not take effect 7 8 unless approved by the people at the general election to be held in November 2020 and, in such case, will take effect on the date of the 9 official declaration of the vote thereon by the governor.". 10
