- 6 Page 6, line 16, strike "2020," and substitute "2022,".
- 7 Page 6, strike line 19 and substitute "SECRETARY'S WEBSITE AND SHALL
- 8 CREATE SIGNS TO BE POSTED BY COUNTY CLERKS AT ALL VOTER SERVICE
- 9 AND POLLING CENTERS TO INFORM ELECTORS".
- 10 Page 6, line 21, strike "TIME THAT" and substitute "FIRST DAY THAT
- 11 DOMESTIC".
- 12 Page 6, line 22, strike "BECOME AVAILABLE" and substitute "ARE
- 13 MAILED".
- 14 Page 6, strike lines 24 and 25 and substitute "BETWEEN SEVEN IN THE
- 15 MORNING AND SEVEN IN THE EVENING BEGINNING THE FIRST DAY THAT

- 1 DOMESTIC BALLOTS FOR STATEWIDE GENERAL AND COORDINATED
2 ELECTIONS ARE MAILED TO ELECTORS THROUGH ELECTION DAY."
- 3 Page 7, line 23, strike "SURVEY," and substitute "SURVEY OR COMPARABLE
4 CENSUS DATA,".
- 5 Page 8, line 1, strike "SURVEY," and substitute "SURVEY OR COMPARABLE
6 CENSUS DATA,".
- 7 Page 8, line 11, strike "SURVEY." and substitute "SURVEY OR COMPARABLE
8 CENSUS DATA.".
- 9 Page 8, strike lines 19 through 21 and substitute "APPLICABLE LANGUAGE
10 OF ALL CONTENT THAT IS CERTIFIED TO THE COUNTY CLERKS BY THE
11 SECRETARY OF STATE. THE COUNTY CLERK".
- 12 Page 9, strike lines 3 through 14 and substitute "ANY MINORITY LANGUAGE
13 SPOKEN IN THE COUNTY.".
- 14 Page 9, strike lines 16 through 18 and substitute "OF THE SAME CONTENT
15 THAT IS ON THE ENGLISH LANGUAGE BALLOT.".
- 16 Page 10, strike lines 16 through 19 and substitute "BY ONE OR MORE
17 QUALIFIED TRANSLATORS.".
- 18 Page 11, line 3, strike "SURVEY," and substitute "SURVEY OR COMPARABLE
19 CENSUS DATA,".
- 20 Page 11, line 8, strike "SURVEY," and substitute "SURVEY OR COMPARABLE
21 CENSUS DATA,".
- 22 Page 11, strike lines 13 through 15 and substitute "INCLUDE ALL OF THE
23 SAME CONTENT THAT IS ON THE ENGLISH LANGUAGE BALLOT.".
