After consideration on the merits, the Committee recommends the following:

HB20-1116 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

1 Amend reengrossed bill, page 3, line 6, strike "In" and substitute
2 "(I) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4)(b)(II) OF THIS
3 SECTION, in".

4 Page 3, after line 20 insert:

5 "(II) (A) FOR THE 2020-21 STATE FISCAL YEAR, THE STATE,
6 THROUGH THE OFFICE, SHALL CONTRIBUTE THE LESSER OF THE QUALIFIED
7 ENTITY'S CONTRIBUTION TO THE PREVIOUS CONTRACT YEAR'S STATE'S
8 INVESTMENT OR TWO HUNDRED THOUSAND DOLLARS TO THE TOTAL
9 AMOUNT OF THE STATE'S INVESTMENT IN THE PROCUREMENT TECHNICAL
10 ASSISTANCE PROGRAM FOR THE APPLICABLE CONTRACT YEAR; EXCEPT
11 THAT, FOR THE 2020-21 STATE FISCAL YEAR, THE GENERAL ASSEMBLY
12 SHALL NOT PROVIDE MORE THAN ONE HUNDRED SEVENTY-FIVE THOUSAND
13 DOLLARS FROM THE GENERAL FUND. THE OFFICE SHALL PROVIDE, WITHIN
14 EXISTING RESOURCES, THE REMAINING TWENTY-FIVE THOUSAND DOLLARS
15 TOWARD THE STATE'S INVESTMENT FOR THE 2020-21 STATE FISCAL YEAR.

16 (B) FOR THE 2021-22 STATE FISCAL YEAR, THE STATE, THROUGH
17 THE OFFICE, SHALL CONTRIBUTE THE LESSER OF THE QUALIFIED ENTITY'S
18 CONTRIBUTION TO THE PREVIOUS CONTRACT YEAR'S STATE'S INVESTMENT
19 OR ONE HUNDRED SEVENTY-FIVE THOUSAND DOLLARS TO THE TOTAL
20 AMOUNT OF THE STATE'S INVESTMENT IN THE PROCUREMENT TECHNICAL
21 ASSISTANCE PROGRAM FOR THE THEN-CURRENT CONTRACT YEAR.
22 THEREFORE, THE GENERAL ASSEMBLY SHALL NOT PROVIDE MORE THAN

1 ONE HUNDRED SEVENTY-FIVE THOUSAND DOLLARS FROM THE STATE
2 GENERAL FUND OR FROM ANY OTHER SOURCE OF STATE MONEYS IN THE
3 2021-22 STATE FISCAL YEAR.

4 (C) FOR THE 2022-23 STATE FISCAL YEAR AND EACH STATE FISCAL
5 YEAR THEREAFTER FOR THE REMAINDER OF THE TERM OF THE CONTRACT,
6 THE AMOUNT OF THE CONTRIBUTION MADE TO THE STATE'S INVESTMENT
7 AND THE AMOUNT PROVIDED BY THE GENERAL ASSEMBLY FOR SUCH
8 CONTRIBUTION SHALL BE DETERMINED PURSUANT TO SUBSECTION (4)(b)(I)
9 OF THIS SECTION."
