Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB20-1120 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 9, strike lines 11 through 18 and substitute:

2 "SECTION 5. In Colorado Revised Statutes, **add** 17-18-129 as  
3 follows:

4 **17-18-129. Appropriation to comply with section 2-2-703 - HB**  
5 **20-1120 - repeal.** (1) PURSUANT TO SECTION 2-2-703, THE FOLLOWING  
6 STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO IMPLEMENT HOUSE  
7 BILL 20-1120, ENACTED IN 2020:

8 (A) FOR THE 2021-22 STATE FISCAL YEAR, SIX THOUSAND TWO  
9 HUNDRED TWENTY-SIX DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
10 FROM THE GENERAL FUND;

11 (B) FOR THE 2022-23 STATE FISCAL YEAR, SEVEN THOUSAND THREE  
12 HUNDRED FORTY-FOUR DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
13 FROM THE GENERAL FUND;

14 (C) FOR THE 2023-24 STATE FISCAL YEAR, TWENTY-SEVEN  
15 THOUSAND SEVEN HUNDRED SEVENTY DOLLARS IS APPROPRIATED TO THE  
16 DEPARTMENT FROM THE GENERAL FUND; AND

17 (D) FOR THE 2024-25 STATE FISCAL YEAR, THIRTY-NINE  
18 THOUSAND TWO HUNDRED THIRTY-ONE DOLLARS IS APPROPRIATED TO THE  
19 DEPARTMENT FROM THE GENERAL FUND.

20 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2025.

21 **SECTION 6. Appropriation.** For the 2020-21 state fiscal year,  
22 \$636 is appropriated to the judicial department for use by the trial courts

1 division. This appropriation is from the general fund. To implement this  
2 act, the department may use this appropriation for trial court programs.".

3 Renumber succeeding section accordingly.

4 Page 1, line 102, strike "CHILD." and substitute "CHILD, AND, IN  
5 CONNECTION THEREWITH, MAKING AN APPROPRIATION.".
