After consideration on the merits, the Committee recommends the following:

HB20-1230 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 4, line 1, strike "FOR" and substitute "TO
2 FACILITATE".
- 3 Page 4, line 3, strike "DISORDERS." and substitute "DISORDERS WITHIN THE
4 SCOPE OF PRACTICE OF OCCUPATIONAL THERAPY".
- 5 Page 4, line 7, strike "MEAN" and substitute "MEANS".
- 6 Page 6, strike lines 3 through 6 and substitute "PERCEPTUAL, MENTAL,
7 COGNITIVE, AND PAIN FACTORS; BODY STRUCTURES SUCH AS
8 CARDIOVASCULAR, DIGESTIVE, NERVOUS, INTEGUMENTARY, AND
9 GENITOURINARY SYSTEMS; STRUCTURES RELATED TO MOVEMENT; AND A
10 CLIENT'S VALUES, BELIEFS, AND SPIRITUALITY".
- 11 Page 6, line 16, strike "EMOTION," and substitute "EMOTIONAL
12 REGULATION, AND".
- 13 Page 7, lines 25 and 26, strike "AND SCHOOL ACTIVITIES" and substitute
14 "SCHOOL ACTIVITIES;".
- 15 Page 9, line 8, strike "enhance" and substitute "enhance, MAINTAIN, OR
16 PREVENT THE DECLINE OF".
- 17 Page 9, strike line 12 and substitute "SERVICES UNDER THE REFERRAL,
18 PRESCRIPTION, SUPERVISION, OR COMANAGEMENT OF AN

- 1 OPTHALMOLOGIST OR OPTOMETRIST;".
- 2 Page 9, line 20, strike "PERFORMANCE." and substitute "PERFORMANCE
3 WITHIN THE SCOPE OF PRACTICE OF OCCUPATIONAL THERAPY."
- 4 Page 9, line 23, strike "PATIENT" and substitute "CLIENT".
- 5 Page 10, line 21, strike "C.O.T.A.," and substitute "'C.O.T.A.',".
- 6 Page 13, strike line 27 and substitute "DOCTORAL CAPSTONE EXPERIENCE
7 IF THE PERSON ACTS UNDER APPROPRIATE".
- 8 Page 14, strike line 1.
- 9 Page 14, lines 7 and 8, strike "physical therapy, as defined in article 285
10 of this title 12;" and substitute "physical therapy, as defined in article 285
11 of this title 12;".
- 12 Page 14, line 8, strike "vision therapy services" and substitute "vision
13 therapy services".
- 14 Page 14, strike lines 9 through 11 and substitute "~~or low vision
15 rehabilitation services, except under the referral, prescription,
16 supervision, or comanagement of an ophthalmologist or optometrist;~~
17 OPTOMETRY, AS DESCRIBED IN ARTICLE 275 OF THIS TITLE 12; or any other
18 form of healing except as authorized by this".
- 19 Page 14, after line 15, insert:
20 **"SECTION 11.** In Colorado Revised Statutes, 12-270-113,
21 **amend** (1) introductory portion, (1)(a), and (1)(b) as follows:
22 **12-270-113. Protection of medical records - licensee's**
23 **obligations - verification of compliance - noncompliance grounds for**
24 **discipline - rules.** (1) Each occupational therapist and occupational
25 therapy assistant responsible for ~~patient~~ CLIENT records shall develop a
26 written plan to ensure the security of ~~patient~~ CLIENT medical records. The
27 plan must address at least the following:
28 (a) The storage and proper disposal of ~~patient~~ CLIENT medical
29 records;
30 (b) The disposition of ~~patient~~ CLIENT medical records if the
31 licensee dies, retires, or otherwise ceases to practice or provide
32 occupational therapy services to ~~patients~~ CLIENTS; and"

- 1 Renumber succeeding sections accordingly.
- 2 Page 15, line 18, strike "PATIENT" and substitute "CLIENT".
- 3 Page 18, line 15, strike "patient" and substitute "~~patient~~ CLIENT".
