 FROM THE EFFECTS OF THE COVID-19 PANDEMIC;"
- 6 Page 5, after line 17, insert:

 TO THE STATE, THE COUNTY'S SHARE OF SMALL BUSINESS EMPLOYEES
 RELATIVE TO THE STATE, THE COUNTY'S SHARE OF SMALL BUSINESS
 PERSONAL PROPERTY RELATIVE TO THE STATE, OR OTHER SIMILAR METRICS
 AS DETERMINED BY THE OVERSIGHT BOARD. THE MONEY ALLOCATED TO
 EACH COUNTY MUST BE".
