(d) Notwithstanding the requirements of this subsection (2), the committee shall not meet or recommend legislation during the 2020 interim, or during any interim in which the general assembly has suspended interim committee activities, and is not required to submit an annual report to the general assembly on or before January 15, 2021, or any January following the suspension of interim committee activities by the general assembly.  SECTION 2. In Colorado Revised Statutes, 18-1.9-104, add (7) as follows:

20	systems - creation - membership - duties. (7) NOTWITHSTANDING ANY

3	SECTION 3. In Colorado Revised Statutes, amend 18-1.9-107
4	as follows:
5	18-1.9-107. Repeal of article. This article ARTICLE 1.9 is
6	repealed, effective <del>July 1, 2020</del> JULY 1, 2023.
7	SECTION 4. Safety clause. The general assembly hereby finds,
8	determines, and declares that this act is necessary for the immediate
9	preservation of the public peace, health, or safety.".
